#### **MARCH 5, 2024 GENERAL MUNICIPAL ELECTION**

#### DECLARING RESULTS OF THE ELECTION

The City Clerk reported that the canvass of votes for the March 5, 2024, General Municipal Election had been completed by the Los Angeles County Registrar-Recorder/County Clerk. She reported 8,838 ballots had been cast, and that the successful candidates were Jeff Wood for Member of the City Council District 3 and David Arellano for Member of the City Council District 4. It was the recommendation of staff that the City Council adopt Resolution No. 2024-6, declaring the election results.

#### 3.1 • AUTHORIZE PURCHASE OF VEHICLES FOR FY2023-24

Kelli Pickler, Director of Public Works, displayed slides and made a presentation based on the report in the agenda regarding the purchase of replacement vehicles and the regulations that would significantly impact the composition and operation of vehicle fleets in California. She stated it was staff's recommendation that the City Council appropriate the funds, in the total amount of \$330,000, for the purchase of the vehicles as listed in 'Attachment A' of this staff report; authorize the City Manager to approve the purchase of one (1) Chevy Equinox in the amount of \$35,000; authorize the City Manager to approve the purchase of three (3) service body trucks in the amount of \$150,000; authorize the City Manager to approve the purchase of one (1) Light Truck in the amount of \$35,000; and authorize the City Manager to approve the purchase of one (1) Heavy Duty Dump Truck in the amount of \$110,000.
