

Minutes Lakewood City Council Regular Meeting held April 23, 2024

**MEETING WAS CALLED TO ORDER** at 7:36 p.m. by Vice Mayor Rogers in the Council Chambers at the Civic Center, 5000 Clark Avenue, Lakewood, California.

## FILLING THE VACANCY OF OFFICE OF MAYOR

City Manager Thaddeus McCormack made a presentation based on the report in the agenda and stated that the City had recently held elections for City Council Districts 3 and 4 respectively, the result of which was the election of Council Members Arellano and Wood, as well as the vacation of the office of Mayor. He added that accordingly, the City Council should open nominations for offices of Mayor and Vice Mayor and noted that subsequently, staff be directed to bring back the reorganization of Council offices on July 9, 2024, to correspond with the previously established annual reorganization of offices.

Steve Skolnik, for the City Attorney, explained the process of nominating the mayor and vice mayor.

Mayor Rogers announced that the meeting would be adjourned in memory of Mary Elizabeth Strange, a longtime resident and the niece to longtime city commissioner Kirk Real. The Mayor thanked Lakewood community members for their participation in the Make-Up Day for Volunteer Day, which had been rescheduled due to an unusually late season storm two weekends earlier. He commended staff for their efforts on the success of the Family Movie Night event celebrating Lakewood's 70th anniversary since incorporation. The Mayor stated that he was honored to proclaim April 2024 as "Autism Acceptance Month" in Lakewood and encouraged residents to show their support by educating themselves on understanding Autism Spectrum Disorder and the ways to celebrate and empower autistic individuals.

Council Member Wood stated that he had attended a Zombie Apocalypse event hosted by Scout Pack 134. He announced that with the recent closures of local 99¢ Stores and Rite Aid Pharmacies, the Southeast Los Angeles County Workforce Development Board staff had visited impacted stores to provide information on their various assistance programs.

Council Member Arellano reported that he had attended the League of California Cities conference and met with Sacramento lobbyists and legislators regarding housing and homelessness issues.

Mayor Rogers introduced Captain Dan Holguin, commander of the Lakewood Sheriff's Station, who provided the quarterly public safety report.
