SUBJECT: Report of City Council Committees' Activities

INTRODUCTION

A brief update is provided for City Council review on the activities of the following standing committee: Public Safety Committee.

STATEMENT OF FACT

On October 8, 2020, the Public Safety Committee met and discussed:

Me-n-Ed's Pizzeria Entertainment Permit

Me-N-Ed's Pizzeria recently had a change of ownership and was reapplying for their entertainment permit, since the municipal code (LMC) did not allow a transfer of the permit to the new owner. Staff recommended that the License and Permit Hearing Board approve an entertainment permit to Epic Compas LLC for Me-N-Ed's Pizzeria for the times, dates, and manner requested in their application. The Committee approved staff's recommendations.

Staff recognized Administrative Secretary Theresa Gutierrez who was in attendance and would be retiring soon, after nearly 20 years of service for the City of Lakewood. Committee members expressed their appreciation for her service, noting that Lakewood was a better community for her service and dedication.

Crime Trends and Statistics

LASD Personnel reviewed a crime map, which displayed the locations and amounts of Part 1 crime occurrences for the month of August. Staff noted that the map provided great comparative data and visualizations that could help show patterns in crime. LASD Personnel reported that Part 1 crimes were down overall for the period from January to August of this year compared to the same time frame last year. It was noted that there were spikes in grand theft autos (GTAs) and aggravated assaults. LASD will monitor incidents to try to find patterns.

LASD Personnel reported that Part 1 crimes at Lakewood Mall from January to August were down more than 30% overall for the same time frame last year. There were slight increases in aggravated assaults and GTAs at the mall and deputies, which LASD will monitor and assess going forward. LASD Personnel presented the review of Part 1 crimes at Lakewood and Cerritos Malls in 2019, noting that Lakewood had a 23.21 crimes per million visitors rate compared to Cerritos' 32.60 crimes per million visitors. Lakewood had 15.6 million visitors in 2019, while Cerritos had 10 million visitors.

LASD Personnel shared information regarding incidents that led to several arrests including a GTA and domestic issue. The Committee complimented the great work of LASD and thanked staff and LASD personnel for the new visual aids and presentation of data, which helps better explain the crime statistics. The Committee also requested that all of the City Council receive any relevant information from the Lakewood Station Watch Commander summary on a daily basis so that they would be briefed on questions that might come from residents.

Abatement Deputy Update

The Abatement Deputy gave a report on homeless matters throughout the city, which included numerous contacts and offerings of assistance, various clean-ups, clearing vegetation to prevent encampments, pending fence repairs by the Department of Water and Power, and the housing of two homeless individuals. The Committee thanked the Abatement Deputy for his hard work. City staff thanked the Abatement Deputy for his great work with the Union Pacific encampment clean-up and noted that a letter of agency was received to enable the city and LASD to enter and clean-up an area overseen by Union Pacific when necessary. The Committee expressed their full support to the Abatement Deputy and informed him that the City Council and city were willing to provide tools to help him with his work.

Public Outreach

The Public Information Office was working to highlight holiday safety, including pet safety and Public Health guidelines that impact city events. National Night Out and National Preparedness Month were widely publicized. In the coming months, staff will publicize the increased activity in Public Safety based on the new city budget, along with the new department logo and outreach efforts. Holiday season safety stories would also be published soon.

Community Dialogue Update

Staff reported that the Community Dialogue Town Hall meetings and Weekend of Dialogue congregation visits by Mayor Rogers and Council Member Stuckey were well received. These efforts will be featured in an upcoming Mayor video. Staff is working to summarize and organize the notes from the Town Halls, congregation visits, and written submissions from the community for the City Council. From there, staff will make recommendations for moving forward and seeking input from the public. The Committee expressed their appreciation for all of the updates and information they received throughout this process.

Award of Valor Review

Staff noted that a resident encouraged the formation of a "Bridge Builder Award," which was also a suggestion of staff. It could be awarded to individuals, organizations, or programs that promote racial harmony, good will between various groups and or help build a sense of community amongst individuals and groups of any type in Lakewood, the latter of which is meant to provide for a flexibility in future year recipients such that the award is not just limited to building bridges between racial groups. In the future, staff could ask for nominations from community groups for the "Bridge Builder Award." Staff added that criteria for the award would be created and would include an overall law enforcement connection through promoting a safe community and strengthening ties amongst residents. The Committee requested that creating a

sense of wellbeing be included in the award criteria as well. Chairman Rogers noted that some people currently had the perception of being unsafe and underserved in regards to public safety and noted that community building could help mitigate those feelings and ensure that Lakewood was a welcoming and safe community for all.

Staff reported updated modifications to the annual Award of Valor event due to COVID-19. Award recipients would arrive, park in lot behind The Centre, and have three stops: check in, receive their awards, and then be interviewed by CityTV for the event's video. Staff was putting together time slots for honoree group arrivals and had a contingency plan to move the event safely inside of The Centre in case of rain. Honorees would be discouraged from bringing guests to the event since it would move along quickly and invite letters to honorees would note that there would be a video and photographs available from the event the share with their loved ones at a later time.

Public Safety Department Update

Staff introduced and welcomed Elizabeth Loera, the new Administrative Secretary. Two of the new Community Services Officers will begin work in the field soon and the recruitment process for the new Public Safety Supervisor position was approaching the interview phase.

Virtual Coffee with a Deputy, and Neighborhood Watch Quarterly Seminar events would be the final special events of the year. Most virtual Public Safety events had been videoed for people to watch after the fact and staff was working to make future events interactive for participants.

Public Safety staff thanked Public Information staff for their partnership in promoting National Preparedness Month in new and additional ways this year and noted that lots of great feedback was received. Staff reported that the Los Angeles County Department of Public Health was informing cities about medical points of distribution (MPODS) that could be used to provide flu shots to residents and potentially become sites for COVID-19 vaccinations, when a vaccine becomes available.

Use of Force Policies

Staff was preparing for the community engagement phase of the Mayor's Pledge and proposed an eMag and LCN article requesting feedback on LASD's use of force policy. The article would include a link to the policy and request input, experiences in Lakewood, and recommendations related to the policy. The community would have until November 9 to respond, after which the Committee would review the feedback, decide what recommendations to make to LASD and report back to the community. The Committee approved staff's plan, noting the importance of clarifying with the public that the while the city may be making recommendations to LASD, the authority to make changes to the policy lies with LASD and the County. The Committee also requested that the City Council receive notification when the articles are ready and before they get delivered to residents.

Staff presented the Committee with a handout detailing Measure J, which would be on the ballot for the November 3 election.

Miscellaneous

Committee Member Wood stated that he was seeing illegal vendors throughout the city and staff noted that they would remind field staff to report illegal vendors and any other service request occurrences that they see when working out in the community. Staff also noted that Community Services Officers were monitoring busy intersections to look out for illegal vendors.

INVESTMENT GLOSSARY

ABS (Asset-Backed Securities)

A mortgage pass-through security, collateralized mortgage obligation, mortgage-backed or other pay-through bond, equipment lease-backed certificate, consumer receivable pass-through certificate, or consumer receivable-backed bond.

AGENCY (U.S. Government Agency Issues)

Federal agency or United States government-sponsored enterprise obligations, participations, or other instruments, including those issued by or fully guaranteed as to principal and interest by federal agencies or United States government-sponsored enterprises. There are no portfolio percentage limits for U. S. Government Agency issues.

BOND (Municipal Bonds or Note)

Registered treasury notes or bonds issued by states or municipalities, including bonds payable solely out of the revenues from a revenue-producing property owned, controlled, or operated by a state or by a department, board, agency, or authority of any of the other 49 United States, in addition to California.

CAMP (California Asset Management Program)

A Joint Powers Authority established in 1989 by the treasurers and finance directors of several California public agencies to provide an investment pool at a reasonable cost. Participation is limited to California public agencies.

CD (Certificate of Deposit)

Negotiable CDs are issued by large banks and are freely traded in secondary markets as short term (2 to 52 weeks), large denomination (\$100,000 minimum) CDs, that are either issued at a discount on its par value, or at a fixed interest rate payable at maturity.

COM (Commercial Paper)

Commercial paper of "prime" quality of the highest ranking or of the highest letter and number rating as provided for by a nationally recognized statistical-rating organization.

CORP (Corporate Notes)

Medium-term notes, defined as all corporate and depository institution debt securities with a maximum remaining maturity of five years or less, issued by corporations organized and operating within the Unites States or by depository institutions licensed by the United States, or any state and operating within the United States.

FNMA (Federal National Mortgage Association)

A government-sponsored, privately owned corporation established to create a secondary market for Federal Housing Administration mortgages.

LAIF (Local Agency Investment Fund, State of California)

The Treasurer of the State of California administers this investment pool, providing a high-level of liquidity and strong safety through diversification of investments.

MMF (Money Market Fund)

This is a money market interest-bearing checking account that is fully insured and collateralized.

SUPRA (Supra-National Agency Bonds or Notes)

Supranational bonds and notes are debt of international or multi-lateral financial agencies. The debt is used to finance economic/infrastructure development, environmental protection, poverty reduction and renewable energy around the globe, rated AAA, highly liquid and issued in a range of maturities.

TREAS (U.S. Treasury Notes)

A Treasury obligation of the U.S. Government to provide for the cash flow needs of the Federal Government.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LAKEWOOD EXTENDING A LOCAL EMERGENCY DUE TO THE COVID-19 VIRUS.

THE CITY COUNCIL OF THE CITY OF LAKEWOOD DOES RESOLVE AS FOLLOWS:

SECTION 1. On March 24, 2020, the City Council adopted Resolution No. 2020-5, ratifying a Proclamation of a Local Emergency that the City Manager, acting in his capacity as the City's Director of Emergency Services, had issued on March 17, 2020, due to the COVID-19 virus. On May 12, 2020, the City Council adopted Resolution No. 2020-14, extending such Local Emergency. On June 23, 2020, the City Council adopted Resolution No. 2020-35, extending such Local Emergency. On July 28, 2020, the City Council adopted Resolution No. 2020-37, extending such Local Emergency. On September 22, 2020, the City Council adopted Resolution No. 2020-52, extending such Local Emergency. The City Council hereby extends such Local Emergency, on the same terms and conditions.

SECTION 2. The Local Emergency shall remain in effect until terminated by the City Council. The City Council shall review the need for continuing the Local Emergency at least once every 60 days until the City Council terminates the Local Emergency, as required by section 8630 of the California Government Code.

SECTION 3. If any section, subsection, subdivision, paragraph, sentence, clause or phrase in this Resolution, or any part hereof, is held invalid or unconstitutional, such decision shall not affect the validity of the remaining sections or portions of this Resolution. The City Council hereby declares that it would have adopted each section, subsection, subdivision, paragraph, sentence, clause or phrase in this Resolution irrespective of the fact that any one or more sections, subsections, subdivisions, paragraphs, sentences, clauses or phrases may be declared invalid or unconstitutional.

SECTION 5. The City Clerk shall certify to the adoption of this Resolution.

SUBJECT: Purchase of a 2021 Chevrolet Silverado C3500 with Dump Body

INTRODUCTION

The FY 2020-21 Adopted Budget includes an appropriation of \$58,000 for the replacement of a service truck in the Recreation & Community Services' Environmental Resources Division (RCS-ERD). The proposed truck, to be outfitted with a dump body, would replace Unit #231.

Unit #231 is a 25-year old stake bed truck with over 183,000 miles. It has exceeded its useful life with a significant cost for needed repairs relative to its current value. If the purchase is approved, Unit #231 will be sold via auction after the replacement vehicle is received.

STATEMENT OF FACT

The Purchasing Officer solicited bids for a 2021 Chevrolet Silverado C3500 Regular Cab with dump body based on specifications provided by the City's Fleet Manager and RCS-ERD. Staff posted the required legal advertisement notices and distributed the bid packages to five potential bidders.

On November 2, 2020, the Purchasing Officer, in the presence of the City Clerk, opened one sealed response received. Subsequently, the Purchasing Officer and Fleet Manager reviewed the bid to confirm that bid specifications had been successfully met and that the bid total was accurate.

Following is a summary of dealers invited to the formal bid process, with the lone bid including sales tax and all other fees and charges:

1.	Penske Chevrolet	\$62,066.85
2.	George Chevrolet	No bid
3.	Harbor Chevrolet	No bid
4.	Paradise Chevrolet	No bid
5.	Rotolo Chevrolet	No bid

Penske Chevrolet of Cerritos provided a responsible and responsive bid meeting the needed specifications. Penske Chevrolet was also selected as the lowest bidder for the purchase of a dump truck for the Water Resources Department in December 2019.

Staff reached out to the various dealers who did not submit a bid. There were various reasons for their lack of participation. One dealer was not agreeable to the penalty clause for an unreasonable delay in delivery of the vehicle. Another dealer forgot to submit a bid. One simply never replied to staff's emails and phone messages.

Given the \$58,000 budget, the recommended purchase requires an additional appropriation of \$4,066.85 from the City's General Fund to cover the \$62,066.85 bid amount. The current budget for the purchase was based on a dealer estimate provided earlier in the year.

STAFF RECOMMENDATION

It is recommended that the City Council authorize the appropriation of \$4,066.85 from the General Fund and purchase of a 2021 Chevrolet Silverado C3500 Regular Cab with dump body in the amount of \$62,066.85 from Penske Chevrolet of Cerritos, CA.

SUBJECT: Refresh Youth Center Rental Agreement for Offices at the Burns Community

Center

INTRODUCTION

At the direction of the Park Development Committee, Recreation and Community Services staff was tasked with securing new tenants for vacant spaces located on the second story of the Burns Community Center.

STATEMENT OF FACT

The organization, Refresh Youth Center, a non-profit agency that mentors teens in the Lakewood community, would like to renew the rental agreement with the City of Lakewood to rent two offices at Burns Community Center, totaling 344 sq. ft. of space.

Refresh Youth Center is a non-profit community organization which seeks to improve local communities within Los Angeles County through mentoring, youth seminars, and community outreach programs. The goal of their program is to prepare children with instruction and motivation to pass any test in life, by fostering a relationship with students that struggle to overcome adversity. This is accomplished through academic achievement, character building, healthy behavior applications, physical fitness, socialization, and career exploration. This mission is accomplished by meeting within the office, off site, and also in group settings. Refresh Youth Center holds office hours Monday through Friday, 8:30 a.m. - 6:30 p.m., with 4-hour workshops offered on occasional Saturdays, which is congruent with the hours of facility supervision at the Burns Community Center. Refresh Youth Center began its operation in 2009, assisting teens in the Compton Unified School District. Refresh moved to Lakewood in 2016 and began assisting students at Hoover Middle School in February 2020. They currently serve about five clients per day in the office, host a book club of 15-20 girls once per week, and offer various seminars, workshops, and outreach programs throughout the community.

Refresh Youth Center has been a successful tenant at the Burns Community Center for the past year. Primarily early in the year, the organization provided several outreach opportunities for youth, while working closely with RCS staff to provide fund raising opportunities and public relations campaigns to promote Refresh Youth Center in the Lakewood community. The programs offered by Refresh are commensurate with the mission of the facility in meeting community needs through human service programs, and although the COVID-19 pandemic is still a roadblock, the executive director intends to broaden the reach of Refresh to other schools in the Lakewood area.

CITY OF LAKEWOOD RENTAL AGREEMENT FOR OFFICES AT THE BURNS COMMUNITY CENTER

This Agreement, made and entered into this 10th day of November, 2020, by and between City of Lakewood, a municipal corporation, hereinafter referred to as "City" and Refresh Youth Center, a California 501(C)(3) non-profit organization, hereinafter referred to as "Tenant."

WITNESSETH:

WHEREAS, the Park Development Committee did on October 29, 2019, recommend the execution of a rental Agreement for space on the second floor of the Burns Community Center, located at 5510 Clark Avenue, Lakewood, California 90712, hereinafter referred to as "Premises" for the operation of a teen mentoring organization by Tenant; and

WHEREAS, Tenant is a non-profit enterprise; and

WHEREAS, Tenant will occupy Premises to perform programs and services such as mentoring, character building, academic achievement, healthy behavior applications, physical fitness, and career exploration for teens; and

WHEREAS, Tenant has agreed to pay for the occupancy of Premises the reasonable value thereof;

NOW, THEREFORE, CITY AND TENANT AGREE AS FOLLOWS:

- 1. City does hereby grant to Tenant the exclusive right and privilege to use and occupy Premises for a one (1) year term commencing December 1, 2020 and terminating November 30, 2021, subject to all the terms, provisions and conditions of this Agreement.
- 2. The square footage of the applicable Premises is three hundred, forty four (344) square feet as depicted in Exhibit A and City does hereby find and determine that the Fair Market rental value of Premises is \$2.25 per square foot. Tenant shall pay the appropriate rent of \$774.00 per month to City for the use of Premises by the 1st day of each calendar month in which Tenant maintains occupancy during the term of this Agreement. Rental payments for any portion of a month shall be prorated accordingly. Should Tenant fail to pay the amount due on or before the 1st day of the month, Tenant agrees to pay, in addition, interest on the amount due at the rate of twelve percent (12%) per annum, or the maximum legal rate, whichever is less.

Rent shall be delivered to:

Attention: Director of Recreation and Community Services

- 3. Tenant shall not operate earlier than 7 a.m. and not later than 6:30 p.m. Monday through Friday. Tenant may offer workshops and seminars for a limited number of hours on prearranged Saturdays by coordinating with City and securing a Facility Use Permit for said Saturdays.
- 4. Tenant shall maintain on Premises complete and accurate books and records of daily attendance open to inspection by City at all reasonable times except as prohibited by patient privacy laws.
- 5. Tenant shall provide all personnel, supplies and equipment necessary for the purpose of conducting its program, and Tenant shall observe and comply with all applicable rules, regulations and laws now in effect or which may be enacted during the continuation of this Agreement by City, Los Angeles County, State of California, and the Federal Government.
- 6. Premises shall be used only for program purposes of Tenant, and shall not be used for any other services or activities that are not of a community nature or of general public benefit. Tenant shall not sublet Premises, or any portion thereof, to anyone, and Tenant shall not assign any of its responsibilities pursuant to this Agreement without the prior, written consent of City.
- 7. Tenant shall indemnify, protect, defend and hold harmless City, its elected or appointed officers, agents, officials, employees, and volunteers from and against any and all losses, liabilities, damages, costs and expenses, including reasonable attorneys' fees and costs to the extent same are caused by any negligent or wrongful act, error or omission of Tenant, Tenant's employees, volunteers, invitees, customers, guests, agents, subcontractors, or contractors operating in the performance of professional services under Tenant.
- 8. Tenant certifies that it is aware of the provisions of the Labor Code of the State of California, which require every employer to be insured against liability for workers compensation or to undertake self-insurance in accordance with the provisions of that code, and it certifies that it will comply with such provisions before commencing the performance of the work of this Agreement.
- 9. Tenant shall, at all times during the term of this Agreement, maintain and keep in full force and effect, the following policies of insurance with minimum limits as indicated below and issued by insurers with A.M. Best ratings of no less than A-: VI:
 - Commercial General Liability Insurance using Insurance Services Office "Commercial General Liability" policy form CG 00 01 or the exact equivalent. Defense costs must be paid in addition to limits. There shall be no cross liability exclusion for claims or suits by one insured against another. Limits shall be no less than \$1,000,000.00 per occurrence for all covered losses and no less than \$3,000,000.00 general aggregate.

• Workers Compensation Insurance on a state-approved policy form providing statutory benefits as required by law with employer's liability limits no less than \$1,000,000.00 per accident for all covered losses.

All insurance required by this section shall apply on a primary basis. Tenant agrees that it will not cancel or reduce said insurance coverage during the term of Agreement.

Tenant agrees that if it does not keep aforesaid insurance in full force and effect City may immediately terminate this Agreement.

- 10. Tenant shall at all times be responsible for the planning and operation of the program and City's participation therein is only that of landlord as herein provided. City shall not be responsible for any costs and charges incurred in the conducting of said program when due and owing.
- 11. No person employed by Tenant in the performance of the program shall be deemed a City employee.
- 12. This Agreement is subject to the following conditions and that this Agreement may be terminated by City if any of said conditions should be breached:
 - a. Although Premises shall be under the exclusive occupancy of Tenant, City reserves through the Director of Recreation and Community Services, in whom is vested over-all supervision of the use of said Premises, or any agent or employee thereof, the right to enter said Premises, or any agent or employee thereof, the right to enter said Premises at any time for the purpose of ascertaining compliance with the terms and provisions of this Agreement. City also reserves the right to enter Premises for necessary maintenance and repair of building equipment and systems and for any security reasons.
 - b. The use of Premises and the program conducted therein shall be nondiscriminatory on the ground of race, color, religion, sex, sexual orientation, gender identity or expression, age, disability, marital status, citizenship, national origin, genetic information, or any other characteristic protected by law
 - c. Tenant shall comply with or cause to be complied with any rules and regulations promulgated by City with respect to the maximum occupancy of Premises. Any such rules shall be kept posted at all times on Premises.
 - d. Tenant acknowledges responsibility to see that said rules and regulations are complied with by Tenant's employees, volunteers, invitees, customers, guests, agents, subcontractors, or contractors operating in the performance of professional services under Tenant.
 - e. No alteration, addition, sign, structure, or fixture shall be made or placed in or on the interior or exterior of said Premises without the prior, written consent of City. Any alteration or addition installed or constructed by Tenant with the

consent of City shall be the sole responsibility and charge of Tenant. Tenant shall protect the building and Premises from any lien or charge whatsoever by reason of said alteration or improvement or addition. All alterations or additions or improvements shall be in accordance with the rules and regulations imposed by City. Tenant shall pay and discharge all liens and obligations of any kind or nature which shall be attached to or be imposed upon said Premises when created or incurred by Tenant.

- 13. City shall provide ground maintenance services and custodial maintenance services as set forth in City's Custodial Maintenance Specifications, Exhibit B. Should additional contract custodial maintenance services be retained by Tenant, City must approve the contractor. City agrees to maintain Premises at the same level and standard as it maintains the remainder of the Burns Community Center as detailed in Exhibit B. Tenant, however, covenants and agrees to keep said Premises in a reasonably clean and satisfactory condition and not to deposit or accumulate on said Premises any unreasonable accumulation of garbage, trash, waste, refuse, or other debris.
- 14. City shall provide utility services, including water, gas and electrical. Tenant shall pay for telephone and other electronic services for computer or cable systems necessary for Tenant. Any changes, alterations or improvements to Premises required for computer or cable systems must be approved by City prior to installation.
- 15. Nothing herein contained shall be construed as giving Tenant any right, title or interest in City's land, building or equipment or fixtures located therein, including any partitions, fixtures, furniture or other equipment installed or provided by City.
- 16. Fixed improvements installed by Tenant shall belong to City and may not be removed by Tenant. City shall replace, repair and maintain all fixed improvements. "Fixed improvements" are identified as construction or installation of equipment that is permanent and remains on Premises if Agreement is terminated.
- 17. Upon termination of this Agreement, Tenant shall vacate and restore Premises, fixtures, furniture and other equipment installed or provided by City to Tenant as part of said Premises, to the same condition they were in upon occupancy by Tenant on December 1, 2019, except where directed otherwise by City, reasonable wear and tear excepted.
- 18. Tenant shall have reasonable and necessary right of access to said Premises and said right of access shall include the right to use the doors, hallways and grounds, restrooms and elevator serving Premises. Nothing, however, herein contained shall be deemed to give or grant to Tenant the right or privilege to occupy any other portion of the Burns Community Center or the right to use any other portion of the Burns Community Center other than those portions of the Burns Community Center building and grounds necessary for the purpose of parking, ingress and egress and appurtenant to the occupancy of Premises.
- 19. In the event of any breach of any material term of this Agreement by either party, the other party may give written notice of intent to terminate, and may terminate this

Agreement should the party in breach fail to cure such breach within fifteen (15) days after the giving of such notice. In the event that the nature of the material breach is such that it cannot be cured, then the non-breaching party may terminate this Agreement five (5) days after giving written notice of such breach.

- 20. This Agreement constitutes the entire Agreement between the parties regarding the subject matter hereof, and supersedes any and all prior Agreements between the parties, whether written or oral.
- 21. <u>Notices</u>. Any notice required to be given hereunder shall be deemed to have been given by depositing said notice in the United States mail in an envelope bearing the proper amount of postage thereon, and addressed as follows:

SUBJECT: Appropriation for Facilities Maintenance Annual Projects

INTRODUCTION

For many years, an appropriation was included within the Capital Improvement Program for modest small projects that have allowed staff to address urgent needs within our facilities. These appropriations were for three general areas: Park Hardscape, Fire and Security Improvements, and Fence Improvements.

STATEMENT OF FACT

Annually, the staffs of the Public Works and Recreation and Community Services department, work together to identify the most pressing needs for our facilities in the areas of hardscape repair, fire and security, and fencing. The amounts traditionally appropriated are as follows: hardscape repair (\$50,000), fire and security (\$25,000), and fencing (\$25,000). Since these are capital projects, the unexpended balances in these projects roll forward into the new fiscal year. The funds come from the reserve for Capital Improvements.

For Park Hardscape, in the past staff has used the funds to repair or replace park walkways, patio slabs, picnic area slabs, driveways, and trash enclosure slabs. Typically, staff attempts to address as many of the needs in a park as possible. This modest expenditure helps to improve safety for facility users, and enhances the appearance of the facility at the same time.

Fire and security encompasses fire alarms, burglar alarms, access controls (fobs) and video surveillance. Many facilities have existing systems that are aging and require eventual replacement. Fences are an on-going need at our facilities, due to aging and damage. Fence repairs and replacements are needed at the Mayfair Pool area as well as Palms Park Patio.

Finally, staff proposes to add one new annual project for Facility Roof Repairs (\$50,000). Our waterproofing consulting engineer who has recently inspected all of our facility roofs has recommended a number of roof replacements. Staff hopes to make modest repairs to preserve some of the roofs not immediately targeted for replacement, and perhaps delay the need to immediately replace some roofs for 1 to 3 years.

RECOMMENDATION

Staff recommends that Council appropriate funds for the Park Hardscape (\$50,000), Fire and Security (\$25,000), Fence (\$25,000), and Facility Roof Repairs (\$50,000) Annual Projects from the reserve for Capital Improvements.

The Community Safety Commission recommends that the City Council adopt the attached resolution authorizing installation of a disabled person designated parking space at 6113 Adenmoor Avenue.

SECTION 1. This Resolution is enacted pursuant to Section 21458 and 22507 of the Vehicle Code of the State of California, and Section 3250.2 of the Lakewood Municipal Code.

SECTION 2. Disabled person designated parking is hereby established on the west side of Adenmoor Avenue, beginning one hundred forty three (143) feet north of the north curb line of Allington Street, continuing north for a distance of twenty (20) feet within the City of Lakewood. No vehicle shall stop, stand or park in said parking restriction unless displaying a special identification license plate or placard issued by the Department of Motor Vehicles pursuant to Section 22511.55 of the California Vehicle Code.

SECTION 3. This resolution shall be effective as long as said restriction is painted and posted in accordance with the requirements of Vehicle Code Section 22511.7 of the California Vehicle Code. In addition, this resolution shall be in effect only as long as Evelyn Owens, a physically disabled person, occupies the house at 6113 Adenmoor Avenue.

SECTION 4. This resolution has been adopted pursuant to a Community Safety Commission recommendation.

SUBJECT: Water Rate Study

INTRODUCTION

The City is in the final year of a multi-year water rate schedule adopted in June 2018 that addresses rates through June 30, 2021. In order to conduct an updated analysis and prepare for setting future year rates, Staff believes it is appropriate to initiate a new water rate study.

BACKGROUND

Last month, Staff issued a Request for Proposal (RFP) for a study to be conducted and received eight responses. Using a comprehensive set of factors (including approach, qualifications, project management, and proposed cost), Staff evaluated the eight submittals received. Raftelis Financial Consultants, Inc. (RFC) was found to be the most suitable consultant for the study.

RFC has extensive experience locally and on a national level. They have in-depth knowledge of all areas related to utility management. Additionally, RFC is very active in the American Water Works Association (AWWA), the largest national organization of water professionals. AWWA is widely recognized as one of the authorities in water rate-setting policies. The current AWWA president is an RFC Director.

At the local level, RFC's proposed project staff has vast experience working with comparable water agencies in southern California. They have a thorough understanding of the City's water utility operations, having conducted the City's last study in 2017. In terms of their pricing, it is important to note that their proposed project fee of \$50,448 includes an optional Proposition 218 public hearing presentation (\$2,490) that is in addition to the scope of the RFP. Staff seeks authorization for \$50,448, however the fee would decrease to \$47,958 if the City elects not to have RFC make this presentation. This item is scheduled to be presented to the Water Resources Committee on Monday, November 9th for a recommendation to the City Council.

STATEMENT OF FACT

In order to address the City's water rates starting July 2021, it is necessary to perform a comprehensive analysis and, if needed, provide required Proposition 218 notices to the public.

RECOMMENDATION

It is recommended that the Council authorize staff to enter into an agreement with Raftelis Financial Consultants, Inc. to conduct a water rate study in the amount of \$50,448.

SUBJECT: Amendment to Agreement for Catered Events at Monte Verde Park

INTRODUCTION

TGIS Catering Services, Inc. (TGIS) has provided the catering and concessionaire services at The Centre since 2010. Staff had been satisfied with the catering and concession services provided by TGIS and had entered into an agreement in October of 2020 to augment their service area to include catered events held at Monte Verde Park.

STATEMENT OF FACT

The current agreement with TGIS to provide catering and concessionaire services at Monte Verde Park requires a \$25,000 cash deposit to be held with the city as security to provide a payment owed to any customer or person under contract with TGIS for catering or concessionaire services whereby TGIS fails to deliver services to customer or person per mutual contract agreement.

TGIS has not been able to conduct catered events in the city at either The Centre or Monte Verde Park since the start of the COVID-19 pandemic in March of 2020. Additionally, there are presently no catered events booked at either facility due to the unforeseeable nature of the current pandemic.

SUMMARY

TGIS has communicated a desire to work with the city to offer catered events at Monte Verde following the current COVID-19 pandemic and provided health and safety protocols by Los Angeles County Department of Public Health.

RECOMMENDATION

Staff recommends that the city suspend the requirement for TGIS to maintain a \$25,000 cash deposit until such time that staff determines that indoor and outdoor gatherings are again permissible by Public Health.

It is the recommendation of staff that the City Council authorize the Mayor and the City Clerk sign the Amendment to Agreement for Catered Events at Monte Verde Park, subject to the approval as to form by the City Attorney, with TGIS Catering Services, Inc.

SUBJECT: Amendment of Agreement for On-Call Hazardous Waste Removal Services with

Ocean Blue Environmental Services, Inc.

INTRODUCTION

Ocean Blue Environmental Services, Inc. has been our on-call service provider to provide hazardous waste removal services for the City of Lakewood. Staff recommends their agreement be amended to increase the not-to-exceed limits for homeless encampment clean-up.

STATEMENT OF FACT

The City relies on hazardous waste removal services to pick up hazardous materials from our City Yards and clean up emergency hazardous waste spills. Ocean Blue Environmental Services, Inc. has the required skills to provide such services. The City has maintained an on-call agreement with Ocean Blue since 2016 which is limited not to exceed of \$35,000. The City typically spends about \$4,500 per year for hazardous material clean-up from Nixon Yard, which is budgeted in the Facilities Maintenance division. The balance of the authorization would be spent for hazardous clean ups from traffic accidents, from a special account for traffic collision damage. The amount expended annually from this account varies based upon the type and frequency of the damage.

For FY20-21, the City has established a new budget account of \$100,000 for homeless encampment clean-ups. Ocean Blue has the required skills to perform those clean-ups. Staff recommends authorizing an amendment to their agreement to increase the not-to-exceed (NTE) limit, to allow for the additional \$100,000 budget amount for homeless clean ups. The revised NTE limit would total \$135,000, to allow for the timely cleanup of hazardous waste and homeless encampments. The homeless clean up expenditures will be authorized by the City Manager on a case by case basis.

RECOMMENDATION

Staff recommends that the City Council:

Amend the environmental services agreement with Ocean Blue Environmental Services, Inc., for a period ending June 30, 2021, to increase the not-to-exceed limit to \$135,000 per year, and authorize the Mayor and City Clerk to sign the amendment in a form approved by the City Attorney.

INTRODUCTION

In response to the coronavirus pandemic, the U.S. Department of Housing and Urban Development ("HUD") announced the Coronavirus Aid, Relief and Economic Recovery Act ("CARES Act") which makes available supplemental CDBG funding ("CDBG-CV") to entitlement communities to prevent, prepare for, and respond to coronavirus. On April 28, 2020, the City of Lakewood City Council approved a CDBG-CV allocation of \$289,937. After spending the funds on various approved activities, there are \$32,323 that will need to be reallocated. Under the direction of HUD, an entitlement city is required to submit a Substantial Amendment of the FY 2020-2024 Consolidated Plan if it plans on reallocating funds or changing activities. This proposed amendment will reallocate funding from certain activities to others.

STATEMENT OF FACTS

On April 28, 2020, the City of Lakewood City Council approved a CDBG-CV allocation of \$289,937 to prevent, prepare for, and respond to the coronavirus pandemic. The CARES Act provides that grantees may use CDBG-CV grant funds to cover or reimburse costs to prevent, prepare for, and respond to coronavirus incurred by a State or locality, regardless of the date on which such costs were incurred, when those costs comply with CDBG requirements. It also eliminates the 15 percent cap on the amount of grant funds that can be used for public service activities. In addition, it can used to assist private, non-profit businesses and economic development activities.

Proposed Activities

The approved activities using CDBG-CV funding within Lakewood's FY 2020-2024 Consolidated Plan Substantial Amendment are listed in the table below, with the actual allocation for each activity of the budgeted \$289,937 CDBG-CV entitlement:

HUD recently announced that it will be issuing a third round of CDBG-CV funds. The City was notified that it will receive an additional \$549,214 in funding. Substantial Amendment No. 3 will be prepared at a later date and brought to the City Council for approval.

Public Notice

CDBG guidelines require at least one public hearing to obtain citizen input prior to the adoption of the Consolidated Plan Amendment. During a Federally declared emergency, the City's approved process for obtaining citizen input includes one noticed public hearing. Executive Summary

1. Introduction

The Coronavirus Aid, Relief and Economic Security Act (CARES Act) round one had made \$289,937 available to the City of Lakewood. The City of Lakewood City Council approved the Fiscal Year 2020-2024 Community Development Block Grant — Coronavirus (CDBG-CV) Consolidated Plan Substantial Amendment under the CARES Act on April 28, 2020. The CDBG-CV Substantial Amendment approved funding for the prevention of, preparation for and response to the Coronavirus. The approved activities include City Reimbursement (\$111,000), Planning and Administration (\$57,987), Business Support and Development (\$80,950), and Public Service providers (\$40,000).

The second Substantial Amendment is proposed to redirect a portion of CDBG-CV funds that were approved for City Reimbursement (\$16,350) and Business Support and Development (\$15,950) for a total of \$32,300 to Public Service providers. The Public Service providers include Meals on Wheels (\$4,000), Human Services Association (\$6,000), Community Family Guidance (\$6,000), Pathways Volunteer Hospice (\$4,000), Mothers at Work (\$6,000), Su Casa – Ending Domestic Violence (\$5,000) and Refresh Youth Center (\$1,323)

The 2020-2024 Consolidated Plan for the City of Lakewood satisfies the statutory Department of Housing and Urban Development (HUD) requirements for the Community Development Block Grant (CDBG) Program. Under federal regulations and program guidelines established by HUD, the reporting requirements for this program must be combined into one consolidated submission. The process reduces the burden of administering housing and community development programs and strengthens partnerships among all levels of government and the private sector to better enable the City to provide decent housing, establish and maintain a suitable living environment, and expand economic opportunities for all Americans, particularly those that are low and moderate-income.

The Strategic Plan and Action Plan contained within the City of Lakewood 2020-2024 Consolidated Plan (Consolidated Plan) are provided to establish a specific course of action for Lakewood's revitalization of community development. To this end, residents and other members of the community, neighboring jurisdictions, Los Angeles County and other stakeholders play a vital role in meeting the needs and goals of the City and in shaping Lakewood's future.

2. Summary of the objectives and outcomes identified in the Plan Needs Assessment Overview

The City of Lakewood has prepared a strategy for addressing the housing and community development needs described in the Consolidated Plan during the next five years. By law, the strategy must be designed to achieve the following, principally for low and moderate-income households:

- Provide decent housing;
- Promote a suitable living environment; and
- Expand economic opportunities.

The plan also addresses:

- Elimination of slums and blight.
- Elimination of conditions which are detrimental to health, safety, and public welfare.
- Conservation and expansion of housing stock.
- Expansion and improvement of the quantity and quality of community services.
- Better utilization of land and other natural resources.
- Reduction of the isolation of income groups within communities/geographical areas.
- Alleviation of physically and economically distressed areas.

For more details regarding the specific listed objectives and outcome identified in this Plan, please see Section III: Housing and Community Development Strategic Plan. This section discusses the goals, policies, and quantified objectives of the community as listed in the City's Housing Element as well as other Lakewood Planning and policy documents.

3. Evaluation of past performance

Lakewood, in partnership with non-profit organizations continues to monitor and evaluate the performance of the City's CDBG Programs to ensure regulatory compliance. The following list identifies some of the accomplishments realized during FY 2015-2019 (five year period covered by the previous Consolidated Plan):

- During the Fiscal Years 2015-2019 Five-Year Consolidated Plan a total of 47 Single-Family Rehabilitation Loans and 26 Fix-Up, Paint-Up Grants were processed to assist Lakewood's low income residents improve their homes.
- During Fiscal Years 2015-2019 over 1,200 residents were provided community services including
 congregate and delivered meals through Human Services Association and Meals on Wheels;
 counseling for abused and neglected children through Community Family Guidance; and
 Pathways Volunteer Hospice provided non-medical care and assistance to those facing end of
 life conditions.
- During Fiscal Years 2015-2019 over 2,000 code enforcement cases were processed.

- During Fiscal Years 2015-2019 Lakewood's Fair Housing Consultant assisted over 1,200 persons experiencing fair housing issues.
- Lakewood's assistance to Continuum of Care during Fiscal Years 2015-2019 consisted of serving over 230 persons experiencing homelessness. Services include case management, substance abuse counseling, mental health services, medical services, mainstream benefits, emergency shelter, and permanent housing.
- The Burns Community Center improvements were completed during Fiscal Year 2015-2019. The Burns Community Center received necessary upgrades to provide a safe and modernized ADA compliant building. The improvements included the replacement of a non ADA compliant elevator with a compliant elevator, replacement of damaged brick pavers, expansion of the assembly room, expansion of the kitchen utilized by Meals on Wheels, upgrade restrooms to be ADA compliant, add exterior door at exterior stairwell, install an automatic sliding door at entrance, modify window system on second floor, remove built up grade against building, construct a retaining wall, and remove existing siding on building.

The Lakewood Consolidated Plan embodies the City's current Housing Element. Much of the background data, housing issues, goals, objectives, policies and programs of the Consolidated Plan are consistent with the Housing Element, which was last updated on August 13, 2013. The 2010 US Census and updated data from the 2011-2015 and 2013-2017 American Community Survey (ACS) were also used to accurately reflect current demographics and market and inventory conditions. Based upon the Housing Element's goals and objectives, they are then carried forward into the Consolidated Plan as well as the Annual Action Plan for implementation.

At the end of every fiscal year, the City submits its Consolidated Annual Performance Evaluation Report (CAPER) which provides a clear picture of the past year's performance based upon the set goals and objectives. Historically, the City has scored satisfactorily in meeting all of the required and proposed goals and projects.

4. Summary of citizen participation process and consultation process

Citizen participation in the development, implementation and review of the Consolidated Plan is key to the CDBG process. The City has developed a detailed Citizen Participation Plan, which encourages and solicits the participation of its residents and emphasizes the involvement of low to moderate income persons, particularly where housing and community development funds are spent.

The City provides citizens with advance notice of all related materials available for public review as soon as the notice is published. The citizen participation process for the FY 2020-2024 Consolidated Plan Substantial Amendment CDBG-CV CARES Act includes a 5-day public review period of the Amendment to obtain citizen input.

In accordance with the Lakewood Citizen Participation Plan, the following hearing was conducted for the development of the FY 2020-2024 Consolidated Plan Substantial Amendment No. 2 CARES Act:

- Public Hearing: November 10, 2020
- Five-Day Public Review Period: November 2, 2020 November 10, 2020

On November 2, 2020, a notice was published in the <u>Press Telegram</u> announcing the public hearing before the City Council on November 10, 2020 and announced a five-day public comment period that concluded on November 10, 2020. The Draft Consolidated Plan, Substantial Amendment was available for public review on the City of Lakewood website at lakewoodcity.org, in the City Clerk's office and Community Development Department at Lakewood City Hall, 5050 Clark Avenue, Lakewood, California, and at the Angelo M. However, the City partners with a private waste disposal company to offer an annual Neighborhood Clean-Up Program that is operated through the City's Code Enforcement program. The program provides assistance to tenants and property owners in disposing of unsightly and unwanted debris in neighborhoods identified as needing assistance. Each year

a total of six clean-up events are scheduled and each event has three 40-yard roll-off bins or more available to the residents in the vicinity of the bin. Neighborhood residents are notified of the event date and community volunteer assistance is provided. The private waste disposal company donates the bins for this yearly event saving the City \$9,111.96 in rental fees.

The City of Lakewood operates many of the CDBG funded programs and non-CDBG funded programs from City property. For example, Meals on Wheels, Project Shepard, and homeless services are operated out of the Burns Community Center. Human Services Association is operated out of Weingart Senior Center, LAHSA's annual homeless count is operated out of the Mayfair Park Swim Pavilion and Fair Housing services are operated out of Lakewood City Hall.

The Recreation and Community Services Department offer many programs to assist Lakewood's youth. For example, After School Activity Zone is a free drop-in after school program for school-age children, teens and preteens and is held at city parks. Activities include playground games, arts and crafts, homework help and organized sports leagues through the Lakewood Youth Sports Program.

SUBJECT: Proposed Ordinance Making Municipal Code Changes Affecting Parkways and

Public Right of Way

INTRODUCTION

At the City Council study sessions on September 22, 2020 and October 27, 2020, staff presented photos of encroachments into the public right of way, in parkways and in the streets, as well as a mark-up of specific Municipal Code sections. The encroachments presented reflected safety concerns for pedestrians and motorists. An Ordinance has been prepared by the City Attorney to implement the proposed changes to the Municipal code.

STATEMENT OF FACT

Staff has reviewed several sections of the municipal code and proposed changes that would address the concerns raised regarding encroachments in parkways and the streets. While many of the items of concern are already not allowed under the code, some of the changes serve to clarify the prohibitions, while other changes will either allow for prohibitions not previously enumerated, or allow for an expansion of the use of certain materials in the parkways such as artificial turf. Ideally, staff would prefer only turf grass, irrigation, and the City street tree, however we recognize that the drought has stimulated Lakewood residents to replace turf grass with more drought tolerant plants or materials such as small stones or artificial turf.

The following is a summary of sections of the municipal code including a brief description of the proposed modifications, which are included in the proposed ordinance.

4221 Parkways Defined – There was a phrase in the definition that might be interpreted as the city having responsibility for maintenance of plant materials in the parkway. This phrase is proposed to be removed since the city maintains only the city street tree.

4221.1 Prohibited Act on Parkways – This section lays out specific prohibited actions in the parkway, including damaging or removing a city street tree. We have proposed several clarifications in the subsections, including the prohibition of constructed planters and potted plants.

4221.2 Maintenance of Parkway – This section has been added to make clear that it is the responsibility of the adjacent property owner to maintain the parkway and the plant materials within the parkway, except for the city street tree.

- 4321 Encroachment on Public Rights of Way This section lays out specific encroachments as public nuisances. The proposed changes represent clarifications, and a couple of additions that address the concerns previously depicted in the photos. Specifically, language is added to subsection E. including "any plant species that have thorns, spines, or needle-like leaves." A paragraph added at the end of the section provides clarification that only permitted city street trees, turf grass or short ground cover is allowed, and adds decomposed granite, small loose decorative stones or artificial turf as allowed. This paragraph also clarifies that should work need to be done in the parkway, the city is not responsible for replacing or restoring any materials disturbed during the course of the work, and places that responsibility on the adjacent homeowner.
- 4321.1 Examination by Director of Public Works A clarification has been added to this section to allow the Director of Public Works to establish a reasonable time frame in which to remove encroachments, rather than a previously fixed 30 day period in all instances. Some encroachments posing a direct safety concern to the public may need to be removed in a shorter time frame.
- 4321.2 Abatement of Nuisance A clarification has been added to reflect the proposed changes in the section above.
- 4321.4 Prohibition of Storage Containers This section has been added to clearly prohibit placement of storage containers of all types in the public right of way. Staff have been addressing these encroachments for some time, however, these items have been more commercial available. The proposed added section would strengthen our ability to address this problem.
- 4322 Unlawful Discharge of Waste Materials and Deposit of Rocks, Mud...... This section already prohibits many items from being deposited in the public right of way, and the proposed additions would include "construction equipment, heavy equipment, construction machinery, construction materials, pallets, shipping containers, dumpsters or waste containers except as provided by franchise agreements." These items can become a nuisance, an environmental concern, or a safety concern.
- 4325. Trees This change reflects a legacy designation of responsibility in the municipal code, and would substitute the Director of Public Works for the currently designated Director of Recreation and Community Services, as the staff member responsible for landscaping and trees in parkways and public spaces. The Director of Public Works has carried this responsibility for over 30 years.

RECOMMENDATION

Staff recommends that the City Council hold a public hearing and introduce proposed Ordinance No. 2020-6.

THE CITY COUNCIL OF THE CITY OF LAKEWOOD DOES ORDAIN AS FOLLOWS:

- SECTION 1. Sections 4221 and 4221.1 of the Lakewood Municipal Code are hereby amended to read as follows:
- <u>4221. PARKWAYS DEFINED</u>. Parkways are defined as those areas located in that portion of dedicated roads, streets or highways which have been planted with lawn, bush, tree or plant vegetation.
- <u>4221.1. PROHIBITED ACTS ON PARKWAYS</u>. It shall be unlawful for any person to do or commit, or to cause or permit to be done or committed, within or upon any such parkways any of the following:
 - **A.** To pick, dig, remove, destroy, injure, mutilate, top or cut any tree or root system, or any portion thereof growing therein.
 - **B.** To cut, break, injure, deface, remove or destroy any equipment or property therein, or sign, bench or monument placed thereon, or any portion thereof, or to make or place thereon or on any portion thereof any sign, card, mark, writing or printing, display or other similar device.
 - C. To throw, place or dispose of any garbage, refuse or waste on or upon said area.
 - **D.** To allow any vegetation, other than a City street tree, to grow to a height exceeding six (6) inches, or to place any sign, decoration, statue, lawn ornament, potted plant of any size, constructed planter, or device which will impede the safe ingress and egress of persons from vehicles parked at the curb or safe pedestrian use of the abutting sidewalk.
 - **E.** To allow any water or electrical line, wiring, cord, or hose, to run across the parkway area from any adjacent property to any vehicle parked in the public right-of-way.
 - **F.** To allow any storage of basketball hoops, skateboard ramps, bicycle ramps, or other sports equipment.
 - SECTION 2. The following new Section 4221.2 is hereby added to the LMC:
- <u>4221.2 MAINTENANCE OF PARKWAY</u>. The owner of the adjacent property shall be responsible for the installation, maintenance and irrigation of all plant materials in the parkway, except for the planting, trimming, and removal of City street trees.
- SECTION 3. Sections 4321 through 4321.3 of the LMC are hereby amended to read as follows:

4321. ENCROACHMENT ON PUBLIC RIGHTS OF WAY. The City Council does hereby find that the existence of the following encroachments on any public dedicated or acquired sidewalk, street, parkway, alley, lane, court, park or other public place is a public nuisance. It shall be unlawful for any person to construct, install, place, plant or maintain thereon the following:

- A. Fences.
- B. Hedges.
- **C.** Excavations below the top of curb elevation where without a permit.
- **D.** Sprinkler system pipes above ground elevation.
- **E.** Cover growth such as ivy, ice plant and other similar types of vegetation, or any plant species that have thorns, spines, or needle-like leaves.
- F. Retaining wall.
- **G.** Shrubs, signs and trees as well as buildings or fences where the same interfere with the use of said public right of way.
- H. Broken blacktop, concrete and paving.
- **I.** Gates swinging out or over the public right of way.

In parkways, only permitted city street trees, turf grass or ground cover not exceeding six inches in height, decomposed granite, loose decorative colored stone or gravel no larger than 3/4 inch in size or artificial turf shall be allowed. In the event that the City or its agents perform any work in a parkway that requires the removal or displacement of any such materials, the owner of the adjacent property shall be obligated to perform such removal or displacement to give the City or its agents required access, and the City will not be responsible to repair or restore such materials that may be damaged or removed as a result of the subject work.

4321.1. EXAMINATION BY DIRECTOR OF PUBLIC WORKS. The Director of Public Works shall examine or cause to be examined every alleged encroachment on a public dedicated right of way, and if in his opinion such encroachment is a nuisance as defined herein, he shall notify in writing the owner, occupant, lessee or other person having possession of said premises that the continual maintenance or existence of such encroachment constitutes a public nuisance. Once the Director has deemed such encroachments to be a public nuisance, the Director will assign a timeframe in the Director's reasonable discretion for the removal of the items. At that time, said person or persons must remove said encroachment at his own expense within the timeframe set forth; if not so removed within said timeframe the same will be removed by the City and expense thereof charged to said person or persons.

4321.2. ABATEMENT OF NUISANCE. If said nuisance is not so abated by said person within said timeframe the Director of Public Works may cause said nuisance to be abated as provided in this Chapter.

4321.3. ACCUMULATIVE REMEDIES. The remedies set forth in Section 4321, et seq., of this Chapter in accordance with the terms and provisions of this Chapter, or in accordance with the terms and provisions of State law pertaining to the abatement of public nuisances. Any failure under the provisions of this Chapter to record the lien shall not bar collection of cost of abatement of said nuisance either by special assessment proceedings or by other means. The provisions of this Chapter constituting the cost of abatement of said nuisance a lien on said property may be modified by the City Council as it deems necessary in confirming the report of the Director of Public Works in those cases where the City Council should find that a

proportionate share or all of the share of the cost of said work should be borne by the City in the best public interest. Nothing herein contained shall bar the Director of Public Works or any other city officer having a duty to do so to summarily remove any nuisance herein defined without further notice or preceding before the City Council where the continuation of said nuisance endangers the public health, safety and welfare in the use of any publicly dedicated right of way.

SECTION 4. The following new Section 4321.4 is hereby added to the LMC:

4321.4. PROHIBITION OF STORAGE CONTAINERS. It shall be unlawful to place in any public dedicated or acquired sidewalk, street, parkway, alley, lane, court, park or other public space, any storage container, storage bin, shipping container, PODS, or similar portable storage container. "Portable storage container" means a portable, weather-resistant, commercially leased, rented or purchased receptacle designed and used for the storage or shipment of personal property, building materials or merchandise.

SECTION 5. Section 4322 of the LMC is hereby amended to read as follows:

4322. UNLAWFUL DISCHARGE OF WASTE MATERIALS AND DEPOSIT OF ROCKS, MUD, SAND, OIL OR PETROLEUM PRODUCTS ON PUBLIC ROADS, STREETS AND HIGHWAYS. It shall be unlawful for any person to place, deposit or dump, or to cause to be placed, deposited or dumped upon any public roads, streets, highways, alleys, or portions thereof within the City of Lakewood, any dirt, litter, trash, rubbish, debris, furniture, video, audio, or computer equipment, appliances, boxes, clothing, toys, household items, vehicle parts, paint or other hazardous materials, construction equipment, heavy equipment, construction machinery, construction materials, pallets, shipping containers, dumpsters or waste containers except as provided by franchise agreements, or any miscellaneous discarded items, or to cause the flow or discharge of any sewage, animal waste matter, waste matter, swimming and artificial pool drainage, industrial waste, rocks, mud, dirt, sand or unenclosed or encased oil or petroleum products, upon any public roads, streets, highways, alleys, or portion thereof, within the City of Lakewood unless pursuant to permit issued by the Director of Public Works. Animal waste matter as used herein includes the excrement and urine from any animal, including mixed water and animal waste. This section does not have reference to the following, and nothing contained in this Section shall make the following unlawful: (Amended by Ord. 2005-8)

- **A.** The discharge or deposit of mud, rock, sand or dirt where pursuant to a construction permit issued by the City or permit issued by the Director of Public Works;
- **B.** The discharge of oil or petroleum products or animal waste in the normal utilization by vehicles or animals of any public roads, streets and highways;
- **C.** The discharge of any of the foregoing upon any such public road, street or highway where pursuant to permit issued by the Director of Public Works as hereinafter provided.

The Director of Public Works, or upon his refusal or failure to act, the City Manager may issue permits for the limited discharge of any of the foregoing into the public streets, roads and highways, as well as alleys, of the city of Lakewood for limited periods of time under such conditions as will reasonably insure that such discharge will not be detrimental to the public health, safety and welfare. Such permits shall be issued in accordance with the provisions, where applicable, of the Highway Permit Ordinance. A fee shall be charged for the issuance of such

permit in the amount specified in the Highway Permit Ordinance; and if none then in the amount established by the City Council by Resolution. Such permit shall specify the material to be discharged, the date, time and place of discharge, and the amount of discharge.

No person shall violate any provision of this Section or fail to comply with any of the requirements of a permit, if any, issued pursuant to this Section. Any person violating any of said provisions or failing to comply with said requirements shall be guilty of a misdemeanor, as set forth in Section 1200 of the Lakewood Municipal Code. In addition, the City Council hereby finds and determines that this Section is necessary to prevent obnoxious discharge of waste materials and other materials into public roads, streets and highways, and also to prevent obstructions to the free use of public places, roads, streets and highways, as well as to prevent interference with the comfortable enjoyment of life and property by an entire community or a considerable number of persons and that, therefore, the activity herein defined as unlawful, unless regulated pursuant to a permit, is a public nuisance.

SECTION 6. Section 4325 of the LMC is hereby amended to read as follows:

4325. TREES. The Director of Public Works shall have full power and authority over the planting, removal and maintenance of trees and shrubs in or upon any public street or public ground and shall have the right and power to establish rules and regulations relating thereto. Said Director or his delegated representative shall have the power to cause the trimming or removal of any tree or shrub in or upon any public street or public ground which is diseased or is endangered, or which may endanger the security or usefulness of any public streets or sidewalks.

SECTION 7. The City Council hereby declares it would have passed this Ordinance sentence by sentence, paragraph by paragraph and section by section, and does hereby declare the provisions of this Ordinance are severable, and if for any reason any section of this Ordinance should be held invalid, such decision shall not affect the validity of the remaining parts of this Ordinance.

SECTION 8. The City Clerk shall certify to the adoption of this Ordinance. The City Council hereby finds and determines there are no newspapers of general circulation both published and circulated within the City and, in compliance with Section 36933 of the Government Code, directs the City Clerk to cause said Ordinance within fifteen (15) days after its passage to be posted in at least three (3) public places within the City as established by Ordinance.

SUBJECT: Professional Services Agreement (PSA) for design and engineering services for

Well 13A Treatment Plant Project.

INTRODUCTION

Well 13A located at CandleVerde Park was removed from service in March 2020 due to increasing levels of arsenic concentration. A treatment system is required to bring the well back into service. A pilot study was conducted in July 2020 and it determined that removal of the arsenic is feasible.

STATEMENT OF FACT

A Request for Proposal (RFP) for design and engineering services was issued on October 7, 2020, with one qualified bid received from Murraysmith, Inc. by the due date of October 23, 2020. The bid price of \$281,050 received from Murraysmith, Inc. was much higher than our estimates, and the proposed schedule a lot longer than expected, so staff immediately began to look for ways to lower costs related to this bid. After a review of the proposal, staff was able to negotiate prices on certain portions of the proposal, and modify the scope of work to arrive at a more manageable bid price of \$155,000. After negotiating the received proposal and taking into account both their qualifications and previous work performance, City staff confidently selects Murraysmith, Inc. to provide the design and engineering services for the project.

SUMMARY

With a modified scope and negotiated proposal, as well as their qualifications and previous work experience, City staff selects Murraysmith, Inc. to be the consultant for this project. The design phase of this project will begin once this agreement is awarded, then an RFP for construction will be issued with the completed design. The construction phase of the project is expected to begin early 2021 and be completed by June 2021.

FISCAL IMPACT

Water Capital Improvement Program reserve has sufficient funds to cover the project.

RECOMMENDATION

Staff recommends that the City Council:

- 1. Appropriate \$170,000 (which includes a 9.7% contingency) in Water Reserve Fund for Well 13A Treatment Plant Project
- 2. Award a Professional Services Agreement (PSA) in an amount not to exceed \$155,000 to Murraysmith, Inc. of Portland, OR for design and engineering services for Well 13A Treatment Plant Project
- 3. Authorize the Mayor to sign the contract in a form approved by the City Attorney
