SUBJECT: Retirement Plan Investment Advisory Agreement

INTRODUCTION

The City of Lakewood offers three defined contribution plans to its employees, two are 457 plans the other is a 401 plan. The Director of Administrative Services serves as the Plan Administrator. The Plan Administrator has the fiduciary responsibility to ensure as best possible that the plans are serving employees in their best interest.

STATEMENT OF FACT

In an effort to fulfill the employer/plan administrator fiduciary responsibility to provide plans in the best interest of the employees, the City utilized the services of SFG Retirement Plan Consulting, LLC to conduct a review. The review consisted of getting proposals from the three companies that currently provide defined contribution plans and other viable plans in the market, comparing the plans and then negotiating the best fee and interest rate structure. The comparison analysis included an investment advisory fee for fiduciary services.

Fulfilling the fiduciary responsibility that the plan the City offers are in the best interest of our employees takes a high level of knowledge and understanding of the retirement investment marketplace. Negotiating fee structures, investment options and fixed interest rate fund requires professional experience and skill. To meet the ongoing fiduciary responsibility for City of Lakewood employees staff recommends the City enter into an Agreement with SFG Retirement Plan Consulting LLC. Compensation to SFG Retirement Plan Consulting LLC is through a fee on plan assets of 0.25 percent in the first year and 0.18 percent in following years. This fee was included in the overall review and analysis of the plans.

The next steps include an educational campaign for the employees, and the transfer of assets (conversion) from the old plans to the new. The conversion is standard process, and one we have done before with the 401 plan, and consists of moving each participant's investment choice from the current plan to the new plan. For example, a participant who has invested in an index or life-cycle fund will see their money invested in the same funds under the new plan. We will work closely with each participant in the conversion process. The change participants will see is a lower fee schedule, better quality of funds to invest in, and greater flexibility in investment choices and options.

RECOMMENDATION

Staff respectfully recommends that the City Council approve entering into an Agreement with SFG Retirement Plan consulting, LLC, as approved by the City Attorney as to form, and authorize the Director of Administrative Services as the Plan Administrator to execute documents as related to the Agreement.

SUBJECT: Community Safety Commission recommendations for changes in parking restrictions around the Intensive Learning Center

INTRODUCTION

The Community Safety Commission met on April 3, 2017, to consider various community safety matters that included the consideration of requests for changes in parking restrictions around the Intensive Learning Center, a school that is part of the Bellflower Unified School District.

STATEMENT OF FACT

Staff was contacted and received a request from the Principal of the Intensive Learning Center for a School Bus Only zone on the east side of the school on Whitewood Avenue. Staff met with the Principal as well as the Director of Transportation for Bellflower Unified School District and discussed the placement and appropriate location of the desired School Bus Only zone. If approved, the zone would allow only school buses to load and unload from 7:30 AM to 4:30 PM, Monday through Friday. Currently on Whitewood Avenue, there is a No Parking Zone, a 3 Minute Passenger Loading Only zone, and a 20 Minute Parking zone. The proposed 130' School Bus Only zone would be placed in between the 3 Minute and the 20 Minute Parking zones.

The recommended Resolutions provide details of the changes, such as, where each zone begins and ends. This is needed in order to properly post signage and for enforcement.

RECOMMENDATION





SUBJECT: Community Development Block Grant Action Plan Fiscal Year 2017-2018

STATEMENT OF FACTS

The U.S. Department of Housing and Urban Development (HUD) requires the submission of a Five-Year Consolidated Plan for the Community Planning and Development Programs for entitlement cities, such as the City of Lakewood, who receive Community Development Block Grant (CDBG) funding. The City of Lakewood's current Five-Year Consolidated Plan was adopted in 2015 for Fiscal Years 2015-2019.

In addition to the Five-Year Consolidated Plan, HUD requires preparation of an Annual Action Plan that lists the activities the jurisdiction is proposing to fund. The Action Plan explains how it will address both the priority needs and the local objectives within the upcoming fiscal year on an annual basis. The Action Plan includes the anticipated program income and funds expected to be received during the program year that are allocated to meet housing and community development objectives. In preparing the Action Plan for Fiscal Year (FY) 2017-2018, the City is required to hold at least one public hearing to obtain citizen input prior to the adoption of the Action Plan.

Generally, HUD releases the allocation amounts in February to allow entitlement communities to prepare an accurate Action Plan for the upcoming fiscal year to meet the submission deadline of May 15, 2017. As of April 5, 2017, HUD has not released the entitlement amounts. Initially, HUD advised Lakewood to assume the same allocation that it received during FY 2016-2017 (\$529,085) in order to meet HUD's required due date. HUD is now advising entitlement communities not to submit their Action Plans to HUD until the allocations have been released. HUD notice is attached. According to HUD, a grantee may delay submission of its Action Plan to HUD until 60 days after the date allocations are announced, or until August 16, 2017, whichever comes first.

Prior to receiving the direction from HUD, Lakewood was in the process of adopting the Annual Action Plan. A draft document was prepared and the Planning and Environment Commission had conducted a public hearing. Notice of the Action Plan was also given based on the requirements for meeting a deadline of May 15, 2017

Public Notice

HUD requires and has approved the City of Lakewood' Citizen Participation Plan. Pursuant to the Plan, a notice of the public hearing and commencement of a 30-day comment period to obtain citizen input to the proposed FY 2017-2018 Action Plan was published in the <u>Press</u> <u>Telegram</u>, posted at Lakewood City Hall in the City Clerk's office, and posted in two Lakewood public parks, Bloomfield Park and Mayfair Park on February 13, 2017.

ORDINANCE NO. 2017-2

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF LAKEWOOD AMENDING THE MUNICIPAL CODE BY ADOPTING BY REFERENCE COUNTY OF LOS ANGELES FIRE CODE (TITLE 32), COUNTY OF LOS ANGELES BUILDING CODE (TITLE 26), COUNTY OF LOS ANGELES ELECTRICAL CODE (TITLE 27), COUNTY OF LOS ANGELES PLUMBING CODE (TITLE 28), COUNTY OF LOS ANGELES MECHANICAL CODE (TITLE 29), COUNTY OF LOS ANGELES RESIDENTIAL CODE (TITLE 30), COUNTY OF LOS ANGELES GREEN CODE (TITLE 31), AND COUNTY OF LOS ANGELES EXISTING BUILDING CODE (TITLE 33).

THE CITY COUNCIL OF THE CITY OF LAKEWOOD DOES ORDAIN AS FOLLOWS:

SECTION 1. Section 3101 of Chapter 1 of Article III of the Lakewood Municipal Code is hereby amended to read as follows:

"3101. ADOPTION OF THE FIRE CODE. Except as hereinafter provided, that certain fire code known and designated as the Los Angeles County Fire Code is the fire code of the City of Lakewood, adopted by reference. The intent of the code is to prescribe regulations consistent with nationally recognized good practice for the safeguarding, to a reasonable degree, of life and property in Lakewood from the hazards of fire and explosion arising from the storage, handling and use of hazardous substance, materials and devices, and from conditions hazardous to life or property in the use or occupancy of buildings or premises in Lakewood. As used in this chapter, the Los Angeles County Fire Code refers to the current fire code adopted by the County of Los Angeles and any amendments to such code subsequently adopted by the County of Los Angeles. In the event of any conflict between provisions of the Los Angeles County Fire Code, Title 32 of the Los Angeles County Code, or the Lakewood Municipal Code, the provision contained in the Lakewood Municipal Code shall control. One copy of the Los Angeles County Fire Code, as amended, has been deposited in the office of the city clerk of the city of Lakewood, and shall be at all times maintained by the clerk for use and examination by the public."

SECTION 2. Section 8100 of Chapter 1 of Article VIII of the Lakewood Municipal Code pertaining to Building Regulations is hereby amended to read as follows:

<u>**"8100.** ADOPTION OF THE BUILDING CODE.</u> Except as hereinafter provided, that certain building code known and designated as the Los Angeles

County Building Code shall be and become the building code of the City of Lakewood, regulating the erection, construction, enlargement, alteration, repair, moving, removal, demolition, conversion, occupancy, use, height, area, maintenance of all structures and certain equipment therein specifically regulated and grading within the City of Lakewood, and providing for the issuance of permits and the collection of fees therefor, and providing penalties for violation of such code. As used in this chapter, the Los Angeles County Building Code refers to the current building code adopted by the County of Los Angeles and any amendments to such code subsequently adopted by the County of Los Angeles. In the event of any conflict between provisions of the Los Angeles County Building Code, Title 26 of the Los Angeles County Code, or the Lakewood Municipal Code, the provision contained in the Lakewood Municipal Code shall control. One copy of said Los Angeles County Building Code has been deposited in the office of the city clerk of the city of Lakewood and shall be at all times maintained by said clerk for use and examination by the public."

SECTION 3. Section 8200 of Chapter 2 of Article VIII of the Lakewood Municipal Code pertaining to the Plumbing Code is hereby amended to read as follows:

"8200. UNIFORM PLUMBING CODE. Except as hereinafter provided, that certain plumbing code known and designated as the Los Angeles County Plumbing Code shall be and become the plumbing code of the City of Lakewood, regulating plumbing and drainage systems and prescribing conditions under which such work may be carried on within the city, and providing for the issuance of permits and the collection of fees therefor and providing penalties for violation of such code. As used in this chapter, the Los Angeles County Plumbing Code refers to the current plumbing code adopted by the County of Los Angeles and any amendments to such code subsequently adopted by the County of Los Angeles County Plumbing Code, Title 28 of the Los Angeles County Code, or the Lakewood Municipal Code, the provision contained in the Lakewood Municipal Code shall control. One copy of the Los Angeles County Plumbing Code has been deposited in the office of the city clerk of the city of Lakewood, and shall be at all times maintained by the clerk for use and examination by the public."

SECTION 4. Section 8300 of Chapter 3 of Article VIII of the Lakewood Municipal Code pertaining the Electrical Code is hereby amended to read as follows:

<u>**"8300. ELECTRICAL CODE.</u>** Except as hereafter provided, that certain electrical code known and designated as the Los Angeles County Electrical Code shall be and become the electrical code of the City of Lakewood regulating the installation, arrangement, alteration, repair, use and operation of electric wiring, connections, fixtures and other electrical appliances on premises within the city</u>

providing for the issuance of permits and the collection of fees therefor. As used in this chapter, the Los Angeles County Electrical Code refers to the current electrical code adopted by the County of Los Angeles and any amendments to such code subsequently adopted by the County of Los Angeles. In the event of any conflict between provisions of the Los Angeles County Electrical Code, Title 27 of the Los Angeles County Code, or the Lakewood Municipal Code, the provision contained in the Lakewood Municipal Code shall control. One copy of said Los Angeles County Electrical Code has been deposited in the office of the city clerk of the city of Lakewood, and shall be at all times maintained by said clerk for use and examination by the public."

SECTION 5. Section 8400 of Chapter 4 of Article VIII of the Lakewood Municipal Code pertaining to the Mechanical Code is hereby amended to read as follows:

"8400. MECHANICAL CODE. Except as hereinafter provided, that certain mechanical code known and designated as the Los Angeles County Mechanical Code shall be and become the mechanical code of the City of Lakewood providing for the issuance of permits and the collection of fees therefor and providing penalties for violation of such code. As used in this chapter, the Los Angeles County Mechanical Code refers to the current mechanical code adopted by the County of Los Angeles and any amendments to such code subsequently adopted by the County of Los Angeles. In the event of any conflict between provisions of the Los Angeles County Mechanical Code shall control. One copy of said Los Angeles County Mechanical Code has been deposited in the office of the city clerk of the city of Lakewood, and shall be at all times maintained by said clerk for use and examination by the public."

SECTION 6. Section 8800 of Chapter 8 of Article VIII of the Lakewood Municipal Code pertaining to the Residential Code is hereby amended to read as follows:

<u>**"8800. RESIDENTIAL CODE.</u>** Except as otherwise provided in this Chapter, the Residential Code of the County of Los Angeles, sometimes hereinafter referred to as the "Residential Code", known and designated as Title 30 of the Los Angeles County Code is hereby adopted and made a part hereof as though fully set forth in this Chapter. As used in this chapter, the Los Angeles County Residential Code refers to the current residential code adopted by the County of Los Angeles and any amendments to such code subsequently adopted by the County of Los Angeles. Said Code shall regulate the erection, construction, enlargements, alteration, repair, moving, removal, demolition, occupancy, use, equipment, height, area, security, abatement and maintenance of certain residential buildings or structures within the City, and shall provide for the</u>

issuance of permits and collection of fees therefor. One copy of said Los Angeles County Residential Code has been deposited in the office of the city clerk of the city of Lakewood and shall be at all times maintained by said clerk for use and examination by the public.""

SECTION 7. Section 8900 of Chapter 9 of Article VIII of the Lakewood Municipal Code pertaining to the Green Code is hereby amended to read as follows:

<u>"8900. GREEN CODE.</u> Except as hereinafter provided in this Chapter, the Green Code of the County of Los Angeles, sometimes hereinafter referred to as the "Green Code", known and designated as Title 31 of the Los Angeles County Code, is hereby adopted and made a part hereof as though fully set forth in this Chapter, with the amendments hereinafter set forth. Said Code shall regulate the planning, design, operation, construction, use and occupancy of every newly constructed building or structure within the City, unless otherwise indicated in said Code, and shall provide for the issuance of permits and collection of fees therefor. One copy of said Los Angeles County Green Code has been deposited in the office of the city clerk of the city of Lakewood and shall be at all times maintained by said clerk for use and examination by the public."

SECTION 8. The following new Chapter 10, entitled "EXISTING BUILDING CODE", is hereby added to Title VIII of the Lakewood Municipal Code:

"8950. EXISTING BUILDING CODE. Except as hereinafter provided in this Chapter, the Existing Building Code of the County of Los Angeles, sometimes hereinafter referred to as the "Existing Building Code", known and designated as Title 33 of the Los Angeles County Code, is hereby adopted and made a part hereof as though fully set forth in this Chapter, with the amendments hereinafter set forth. Said Code shall regulate the repair, alteration, change of occupancy, addition to, and relocation of every existing building or structure within the City, unless otherwise indicated in said Code, and shall provide for the issuance of permits and collection of fees therefor. One copy of said Los Angeles County Existing Building Code has been deposited in the office of the city clerk of the city of Lakewood and shall be at all times maintained by said clerk for use and examination by the public."

In the event of any conflict or ambiguity between any provisions contained in the Existing Building Code and any amendment thereto, or addition thereto contained in this Chapter, the amendments or additions thereto contained in this Chapter shall control.

<u>8951. SAME. DEFINITIONS.</u> The definitions contained within Section 8101 shall apply equally to this Chapter and whenever any of said names and terms are used in the Existing Building Code, such names or terms shall be deemed and construed to have the meaning ascribed to them in Section 8101, unless otherwise set forth in this Chapter.

<u>8952.</u> AMENDMENTS TO THE EXISTING BUILDING CODE. The amendments to said Existing Building Code herein adopted by reference are set forth in the following sections of this Chapter.

<u>8953. BOARD OF APPEALS.</u> The Board of Appeals, as defined, constituted and appointed by the Building Code, shall hear and determine all appeals and variances necessary and appropriate under the terms and provisions of this Chapter, in accordance with the rules and regulations governing the proceedings of such Board set forth in the Building Code.

<u>8953. FEES AND CHARGES.</u> The fees established by the Existing Building Code may be amended by Resolution of the City Council and except as amended shall otherwise apply in all cases."

SECTION 9. The City Council hereby declares it would have passed this Ordinance sentence by sentence, paragraph by paragraph, and section by section, and does hereby declare the provisions of this Ordinance are severable, and if for any reason any section of this Ordinance should be held invalid, such decision shall not affect the validity of the remaining parts of this Ordinance.

SECTION 10. Adoption of an Ordinance that adopts the Los Angeles County Fire Code, Los Angeles County Building, Electrical, Plumbing, Mechanical, Residential, Green, and Existing Building Codes by reference, with revisions, is exempt under the provisions of CEQA pursuant to State CEQA Guidelines Section 15061(b)(3), since this Ordinance will not involve any substantive changes to the aforementioned codes. Under a 30-day statute of limitations, a notice of exemption will be posted for public review and filed with the County Clerk upon adoption of this Ordinance.

SECTION 11. The City Clerk shall certify to the adoption of this Ordinance. The City Council hereby finds and determines there are no newspapers of general circulation both published and circulated within the City and, in compliance with <u>Section 36933 of the</u> <u>Government Code</u>, directs the City Clerk to cause said Ordinance within fifteen (15) days after its passage to be posted in at least three (3) public places within the City as established by ordinance. This Ordinance shall take effect thirty (30) days after its adoption.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LAKEWOOD AUTHORIZING THE CITY TREASURER TO DEPOSIT FUNDS FOR SAFEKEEPING AND INVESTMENT AND AUTHORIZING WITHDRAWAL OF FUNDS FROM DEPOSITORIES

WHEREAS, Article 2 of Chapter 4 of Division 2 of Title 5 of the Government Code pertains to the deposit and investment of funds of local agencies; and

WHEREAS, pursuant thereto the City Treasurer, with the approval of the City Council, may deposit money necessary to pay the principal and interest on bonds in a bank within or without the State at the place where they are payable. The City Treasurer further is required to deposit the funds of the City in active and inactive deposits in State or national banks, with the objective of realizing maximum return, consistent with prudent financial management; and

WHEREAS, the City Council has from time to time authorized the City Treasurer to invest said funds in certain banks; and

WHEREAS, the City Treasurer would have more flexibility and be better able to carry out the mandate of the law if the City Treasurer, from time to time, may make the determination as to those depositories or investments in which the City's funds are to be placed, all subject to the terms and provisions of said Article 2 of Chapter 4 of Division 2 of Title 5 of the Government Code of the State of California.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF LAKEWOOD DOES RESOLVE AS FOLLOWS:

SECTION 1. Resolution No. _____ pertaining to the deposit and withdrawal of funds is hereby repealed.

SECTION 2. Pursuant to Article 2 of Chapter 4 of Division 2 of Title 5 of the Government Code of the State of California, the City Treasurer is hereby authorized and directed to deposit all funds of the City of Lakewood as therein specified in active or inactive accounts bearing the highest rate of interest as specified in said Government Code, or to invest said funds in those securities as therein specified in said Government Code, all subject to the terms and provisions of Chapter 4 of Title 5 of the Government Code of the State of California.

SECTION 3. The City Treasurer is authorized and directed to execute all necessary documents, authorization and depository agreements to carry out the foregoing. Any State or national bank depository is hereby requested, authorized and directed to honor all checks, drafts or other orders for payment drawn in the City's name on said accounts so made and entered into by the City Treasurer under the manual, electronic, or facsimile signature of Howard L. Chambers, Carol Flynn Jacoby or Diane Perkin; and where countersigned by either the manual, electronic, or facsimile signature of ______, Mayor, or that of ______, Mayor Pro Tem. Said depository shall be entitled to honor and to charge to the City of Lakewood for all such checks for the payment of money regardless of, by whom, or by what means the actual or purported facsimile signature or signatures resemble the electronic specimen from time to time filed with the depository by the City Treasurer.

SECTION 4. The City Clerk is directed to certify to the adoption of this resolution and to procure from each depository selected by the City Treasurer the necessary signature clauses, cards, or authorizations. The City Treasurer is directed to keep on file with each depository selected by him the facsimile signature of the Mayor and Mayor Pro Tem and from time to time file with the depository any changes in said facsimile specimen.
