1.1 • SALE OF ALCOHOLIC BEVERAGES

Community Development Director Sonia Southwell displayed slides and made a presentation based on the memo in the agenda. She reported that the proposed ordinance dealt with three different aspects of alcoholic beverage sales. The first was the sale of alcoholic beverages for off-site consumption from locations less than 6,500 square feet in area. This topic, which had been the subject of a moratorium, had first come before the City Council in October, 2012, with concerns of an undue concentration of such uses and the location of said uses in close proximity to high schools. She reviewed the data on such uses by census tract, as measured by the California Department of Alcoholic Beverage Control (ABC), noting that only two of Lakewood's 19 census tracts were not currently at or over capacity. She advised that the proposed ordinance would prohibit the issuance of a Conditional Use Permit for an off-sale license under the subject description where there were already two or more such licenses within a 300-foot radius, and provide discretion where, even though outside the specified 300 feet, the proposed use would contribute to over saturation of a census tract. The second area addressed by the ordinance was for on-site consumption of alcoholic beverages in conjunction with manufacturing uses. She reported that there was one Type 23 license in the City for a small beer manufacturer. The proposed ordinance would allow the manufacturer to offer on-site consumption for beverages manufactured on the premises, provided they have a license from ABC that allows for on-site tasting as an ancillary use. The final area addressed by the proposed ordinance would adjust language in the Municipal Code relating to on-sale licenses in the C-1 and C-3 zones to be consistent. She concluded by stating that it was the recommendation of the Planning and Environment Commission that the City Council introduce the proposed ordinance and approve the accompanying negative declaration.

Council Member Croft clarified with Ms. Southwell that the microbrewer could offer tastings, but could not sell food or alcoholic beverages other than those manufactured on site.

Responding to questions from Vice Mayor Wood, Ms. Southwell stated that although the new provisions would allow customers to purchase samples of different types of beer to consume on-site, the intent was to sell beer to take home.

1.1 • SALE OF ALCOHOLIC BEVERAGES - Continued

City Attorney Steve Skolnik advised that the intent was to bring the Municipal Code more into line with the types of licenses issued by ABC.

Mayor Rogers opened the public hearing at 7:57 p.m. and called for anyone in the audience wishing to address the City Council on this matter. There was no response.

COUNCIL MEMBER DUBOIS MOVED AND COUNCIL MEMBER CROFT SECONDED TO CLOSE THE PUBLIC. UPON ROLL CALL VOTE, THE MOTION WAS APPROVED:

Council Member Piazza complimented staff on the research and work on this issue. He expressed his concern that the limitations did not provide enough flexibility and might prevent certain unique businesses from locating in Lakewood, even if the business was a desirable one. He inquired if there was a way to differentiate so that a deli-type business was not classified in the same manner as a liquor store or convenience store.

Ms. Southwell clarified that the proposed regulations would not impact a restaurant business that was offering alcoholic beverages for consumption on site, but only off-sale transactions for consumption off-site.

Mayor Rogers noted that it would be very difficult to word the Code to differentiate uses and suggested that a code amendment could be brought before the City Council should a unique type of business want to locate in Lakewood.

The City Attorney presented several options, including separating the issues in the ordinance to allow the City Council to adopt the uncontested portions.

Council Member Croft confirmed from the City Attorney that the City Council could choose to adopt the ordinance as presented and bring an amendment at a later date.

Responding to a question from Council Member DuBois, the City Attorney advised that the distinction between amending the proposed ordinance now or later was insignificant. He did note however, that by adopting the ordinance now, the moratorium currently in place would be ended.

Mayor Rogers stated that although more study on that aspect of the ordinance was clearly needed, he felt it was not good for business to operate under a moratorium any longer than necessary and regulations should be put into place.

Vice Mayor Wood stated that he agreed that it would be preferable to go forward and introduce the ordinance to put regulations into place and make necessary amendments later.

Mayor Rogers stated that he wished to form a City Council ad hoc committee to work with staff on possible amendments. He appointed Council Member Piazza and Vice Mayor Wood to the committee.

1.2 • ADMINISTRATIVE CITATION PROCEDURES

The Director of Community Development displayed slides and gave a presentation based on the memo in the agenda. She stated the City Council's Public Safety Committee had considered the proposed amendment to the Lakewood Municipal Code relating to the Administrative Citation procedures. She reported that the current process for issuing administrative citations for Code violations included a 21-day waiting period which encouraged procrastination in compliance and more expensive procedure through the court system. The proposed ordinance would eliminate the waiting period, make fines due upon issuance of citations, and clarify the appeal hearing procedure. It was the recommendation of staff that the City Council introduce Ordinance No. 2014-4; adopt the related Negative Declaration; and accept and file the Administrative Citation Process Standard Operating Procedures as submitted.

ORDINANCE NO. 2014-4; AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF LAKEWOOD AMENDING CHAPTER 9 OF ARTICLE IV OF THE LAKEWOOD MUNICIPAL CODE REGARDING ADMINISTRATIVE CITATIONS

Responding to a question from Council Member DuBois, Ms. Southwell stated that the time period to pay the fine for an administrative citation was laid out in the Municipal Code and was not affected by the proposed changes.

In response to a question from Council Member Piazza, Ms. Southwell stated that the process included advising the resident that a violation existed and giving a warning before a citation was issued.

Council Member Croft stated that during the Public Safety Committee's consideration of the proposed ordinance, it had been made clear that the goal of the whole code enforcement process was to gain compliance, not to punish violators. He noted that the proposed changes were to prevent anyone from "gaming" the system – by waiting until the very last day of the grace period to remedy the violation. He also stated that the Committee had requested a written policy so the process would be clear to both staff and residents.

Mayor Rogers stated it was important to maintain the balance between over-zealous enforcement and victimization.

1.3 • PURCHASE OF SIX ADA-COMPLIANT MINIVANS

Administrative Services Director Diane Perkin gave a report based on the memo in the agenda and stated there were Proposition C funds available for the purchase of new, ADA-compliant minivans to be utilized for the DASH transit program. She displayed a slide of the proposed vehicle and advised that the purchase could be made through the CalACT/MBTA Purchasing Cooperative Contract. It was the recommendation of staff that the City Council authorize the purchase of six ADA-compliant, 2014 Braun Entervans from Creative Bus Sales in the amount of \$276,532.44.

1.3 • PURCHASE OF VACUUM SYSTEM TRAILER

The Director of Administrative Services displayed a slide and made a presentation based on the report in the agenda. She stated that the Water Resources Department had budgeted funding for the purchase of a Vacuum system trailer to support operations and comply with stormwater regulations. She reported that since bid packages had been distributed to three potential vendors with no response, the Purchasing Officer had requested and received two quotes for the equipment. The lowest quote had failed to meet specifications and upon demonstration, was deemed unsuitable. It was the recommendation of staff that the City Council authorize the purchase of one vacuum system trailer from Pacific Tek in the amount of \$52,320.

Responding to a question from Council Member Croft, Water Resources Director Jim Glancy stated that the equipment was necessary in response to new stormwater regulations which required site clean up with no sediment or runoff.

3.1 • ABC UNIFIED SCHOOL DISTRICT TRUSTEE AREAS

Council Member Croft, noting the ABC Unified School District was moving from at-large elections to a trustee area system to comply with a legal challenge under the California Voting Rights Act, stated he had requested the placement of this item on the agenda because he felt strongly that the City Council needed to take an official position on the issue. After attending the hearing regarding the proposed boundaries for trustee areas at which three different plans had been presented, he stated that of the 45 speakers at the hearing, most had been in favor of Plan C, which would appear to be the best choice for Lakewood residents. The Plans divided the district into seven trustee areas using specific criteria including that the City of Hawaiian Gardens remain wholly within one area; communities of interest be kept intact; areas follow existing election precinct lines; division of school sites; and have approximately the same number of voting age residents. He noted that the Lakewood portion of the District was too large to be contained within a single trustee area. He reported that subsequent to the hearing, three additional Plans had been proposed, including two variations on Plan C, titled C.I and C.II. He stated that Plan C.I would be the worst, most divisive option for Lakewood residents and appeared to have been created to provide separate areas for two incumbent Board Members, while Plan C.II was not as good a distribution of schools.

3.1 • ABC UNIFIED SCHOOL DISTRICT TRUSTEE AREAS - Continued

Vice Mayor Wood stated that he had also attended several meetings, including the three-hour hearing on the original three plans, which were now six plans. He also stated that he was troubled to hear Lakewood referenced at the hearing as an "appendage" to the District and not a community of interest. He expressed support for Plan C, which included all Lakewood schools within the District. He concluded by stating that he also felt the City Council needed to take an stand against Plan C.I and that a letter expressing the City's position be sent to the District and to each Board Member.

Lynda Johnson, Board Vice President of the ABC Unified School District, stated that maintaining communities of interest was an important part of the process. She also stated that she did not yet support any one particular plan and was in attendance to listen. She concluded by stating that she was hearing that the City Council wanted to keep Lakewood as intact as possible and that it was her intent to vote for the map that would best serve all the residents of the District.

Mayor Rogers stated the he was never happy to hear that Lakewood residents were being disenfranchised and that he would like to see as much of the City contained within a single trustee area as possible.

Council Member DuBois also expressed the desire to stand up for the City's residents by taking a position on this matter, and to work to ensure that the Lakewood students were represented properly.

SUBJECT: Low-Income Exemption from Utility Users Tax

INTRODUCTION

The City Council has established certain classes of exemptions from the Utility Users Tax, including service users who qualify for low-income exemptions.

STATEMENT OF FACT

Resolution No. 92-36, which established a low-income exemption based on a service user's total annual income and household size, was last amended on May 14, 2013 by Resolution No. 2013-12. Said Resolution conformed to the income criteria, as defined by the California Public Utilities Commission (PUC), to the levels expiring May 31, 2014 being used statewide by other utility companies. The attached Resolution increases the amount of annual income to be used in determining eligibility for exemption from the utility users tax effective June 1, 2014. Adoption of this resolution will conform to the income criteria used by the City to the current levels as set by the California Public Utilities Commission.



SUDJECT: Permit Applications for Sale of Fireworks

INTRODUCTION

Sections 3105 through 3106 of the Lakewood Municipal Code identify the requirements to be met and the procedures to be followed by applicants for a permit to sell fireworks. Since the Fire Prevention Ordinance was amended in 2002, the number of firework stand permits has declined from 36 in 2001 to 26 in 2014.

STATEMENT OF FACT

Twenty-six (26) organizations have applied for firework stand permits for the 2014 4th of July season. These applicants are the same groups that the Lakewood City Council approved in 2013. All of these organizations have submitted the proper documentation, as required by the Fire Prevention Code. The following lists the organizations and their authorized locations.

SUBJECT: Justice Assistance Grant Program Funding for Criminal Abatement Team

INTRODUCTION

For the last several years, a portion of the city's Crime, Public Nuisance and Property Abatement Team was funded by the Edward Byrne Memorial Justice Assistance Grant (JAG) program. Each year the Federal government establishes the amount of dollars provided for this program.

STATEMENT OF FACTS

The City has been notified that we may claim an entitlement grant of \$20,137 from the Justice Assistance Program and that funding for the deputy on the Abatement Team is an eligible expenditure. The Abatement Team's mission is to identify and "clean up" nuisance single and multiple family housing units and businesses creating a haven for criminal activities. They also address properties that are unsightly, with residents who disturb the peace and safety of Lakewood neighborhoods. The special assignment deputy is a key member of this team and a portion of the contract cost of this deputy can be offset by this grant.

The JAG program requires the City Council to hold a public hearing on the expenditure of these funds and have a 30-day period whereby comments may be received on this use of grant funds. If the City Council acts and conducts the hearing at this meeting, we will satisfy the required review period on June 12, 2014.

RECOMMENDATION

Staff recommends the City Council approve the submittal of the JAG Program funding for the Crime, Public Nuisance and Property Abatement Team deputy; receive public comment on this grant and accept these comments in the City Clerk's office until June 12, 2014; authorize the City Manager to apply for the grant and forward any additional public comment at the end of the review period; and direct the Director of Administrative Services to appropriate \$20,137 in the 2014 JAG grant fund when the grant is awarded.

ORDINANCE NO. 2014-3

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF LAKEWOOD AMENDING THE LAKEWOOD MUNICIPAL CODE PERTAINING TO THE SALE OF ALCOHOLIC BEVERAGES FOR OFF-SALE CONSUMPTION FROM LOCATIONS LESS THAN 6,500 SQUARE FEET IN AREA, FOR ON-SITE CONSUMPTION IN CONJUNCTION WITH ALCOHOLIC BEVERAGE MANUFACTURING IN THE M-1 (LIGHT MANUFACTURING) ZONE, AND FOR ON-SALE LICENSES IN THE C-1 AND C-3 ZONES.

THE CITY COUNCIL OF THE CITY OF LAKEWOOD DOES ORDAIN AS FOLLOWS:

SECTION 1. Article IX Planning - Zoning of the Lakewood Municipal Code is hereby amended as provided in this Ordinance pursuant to Public Hearings before the Planning and Environment Commission and the City Council.

SECTION 2. CEQA. The City Council finds that an Initial Study has been prepared for the proposed project, pursuant to Section 15063 of the California Environmental Quality Act Guidelines, as amended. A Negative Declaration has been prepared for the project, pursuant to Section 15070, et. seq., of the Guidelines. The project was found to have no significant effect on the environment. Therefore, said Negative Declaration is hereby approved.

SECTION 3. PURPOSE. This ordinance regulates the approval of establishments offering alcoholic beverages for on-site consumption in the C-1 and C-3 zones, it regulates the approval of establishments offering alcoholic beverages for off-site consumption from locations with a gross floor area of less than 6,500 square feet in area, and it regulates the approval of licenses to allow on-site consumption of alcoholic beverages in conjunction with alcoholic beverage manufacturing in the M-1 (Light Manufacturing) zone.

SECTION 4. Section 9340 of Part 4 C-1 (Neighborhood Commercial) Zone Regulations of Chapter 3 Zoning of Article IX of the Lakewood Municipal Code is amended by correcting Subsection 9340.B.4, deleting Subsection 9340.B.26 regarding liquor stores, and by amending Subsection 9340.C.4 regarding the sale of alcoholic beverages for off-site consumption, to read as follows:

9340. USES PERMITTED

B. Retail stores, shops, businesses, and services, including, but not limited thereto, the following:

26. Liquor store not used

C. The following uses provided in each instance a conditional use permit has been obtained and continues in full force and effect:

4. Aleobolie Beverage Establishment, Off-Sale.

(a) Any premise within the City which has not exercised any of the rights and privileges conferred by a retail license issued by the State Department of Alcoholic Beverage Control prior to July 1, 1999, shall first obtain a conditional use permit to dispense alcoholic beverages for off-site consumption. Except where located within a Regional Shopping Center, no conditional use permit shall be approved to sell alcoholic beverages for off-site consumption where the gross floor area of the establishment is less than 6,500 square feet and where there are two or more active off-sale licenses within 300 feet of the proposed off-sale license location. For the purposes of this section the distance between the proposed and active license locations shall be measured from the property boundary of the proposed off-sale license premise to the nearest property boundaries of the active off-sale licenses.

SECTION 5. Section 9347 of Part 4a C-3 (Intermediate Commercial) Zone Regulations of Chapter 3 Zoning of Article IX of the Lakewood Municipal Code is hereby amended by deleting Subsection 9347.A.4 regarding on-sale consumption of alcoholic beverages and by amending Subsection 9340.C.4 regarding the sale of alcoholic beverages for off-site consumption, to read as follows:

9347. USES PERMITTED.

B. Retail stores, shops and businesses, including but not specifically limited thereto the following:

4. Bars, cocktail lounges, or any place offering alcoholic beverage for sale for consumption on the premises, and where in connection with a bona fide cating establishment as defined by the Business and Professions Code as the principal use, or a hotel or motel; provided that no outside door to such bar, cocktail lounge or place where such beverage is consumed is located within two-hundred feet of land zoned for residential uses.

C. RESTRICTIONS ON CERTAIN USES.

2. Bars, eocktail lounges, or any establishment offering alcoholic beverage for sale for consumption on the premises as the principal use.

SECTION 6. Section 9360 of Part 6 M-1 (Light Manufacturing) Zone Regulations of Chapter 3 Zoning of Article IX of the Lakewood Municipal Code is bereby amended by amending Subsection 9360. A regarding the sale of alcoholic beverages for on-site consumption, to read as follows:

9360. USES PERMITTED.

A. Any use permitted in the C-4 Zone under the same specified conditions, except that the following shall not be permitted:

6. Bars, cocktail lounges, or any place offering alcoholic beverages for sale for consumption on the premises, except where in connection with a private club or a bona fide eating establishment as defined by the Business and Professions Code

> or a manufacturer of alcoholic beverages where said alcoholic beverages are manufactured on the premises and where a license has been granted by the Department of Alcohol Beverage Control, and provided, further, that no outside door to such bar, cocktail lounge or place where said beverage is consumed is located within two hundred feet of land zoned for residential uses.

SECTION 7. SEVERABILITY. ORDINANCE NO. 2014-4

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF LAKEWOOD AMENDING CHAPTER 9 OF ARTICLE IV OF THE LAKEWOOD MUNICIPAL CODE REGARDING ADMINISTRATIVE CITATIONS.

THE CITY COUNCIL OF THE CITY OF LAKEWOOD DOES ORDAIN AS FOLLOWS:

SECTION 1. Subsection 4903.A. of the Lakewood Municipal Code, regarding "Administrative Citation, Authority to Cite" is hereby amended to read as follows:

A. Whenever an Enforcement Officer determines that a violation of this Code or a City ordinance has occurred, the Enforcement Officer shall have the discretion to issue an administrative citation, in lieu of a judicial citation or misdemeanor, to any legally responsible person. Unless the violation creates an immediate danger to health or safety, the cited person shall be given not less than 21 calendar days to correct or otherwise remedy the violation before imposition of administrative fines or penalties.

SECTION 2. Subsection 4905.C. of the Lakewood Municipal Code, regarding "Remedy of the Violation" is hereby deleted.

REMEDY OF THE VIOLATION.

C. If the cited party remedies the violation within the time indicated on the citation, upon verification by the enforcement officer, the cited party shall not be obligated to pay a fine for the corrected violation.

SECTION 3. Subsection 4906.F.2. of the Lakewood Municipal Code, rcgarding "Failure to Attend Administrative Hearing" is hereby amended to read as follows

2. A citcd party who has requested an administrative hearing may request in writing that his or her challenge to the citation be dismissed and the hearing canceled. Upon receipt of such request, the administrative hearing officer Director of the Community Development Department shall dismiss the challenge to the administrative citation, cancel the pending hearing, and issue a written notice to that effect. The advance deposit shall then become the property of the City.

SECTION 4. Subsection 4906.H. of the Lakewood Municipal Code, regarding "Decision of Administrative Hearing Officer" is hereby amended to read as follows:

H. At the conclusion of the hearing or within 15 days thereafter, the Administrative Hearing Officer shall render a decision as follows:

- 1. Determine that the violation for which the citation was issued occurred, and impose a fine in the amount set forth in the schedule of administrative fines and, if the violation has not been corrected as of the date of the hearing, order correction of the violation by a certain date. and require payment of the pertinent fine not later than seven days after the date of such determination, in the event that an Advanced Deposit Hardship Waiver had been approved. If the violation has not been corrected by the date of the hearing, the Director of Community Development shall send a notice of the required correction date, within 10 days of receipt of the Administrative Hearing Officer's decision.
- 2. Determine that the violation for which the citation was issued occurred, but that the responsible party has introduced credible evidence of mitigating circumstance warranting imposition of a lesser fine than that prescribed in the schedule of administrative fines, or no fine at all, and imposing such lesser fine, if any., and if the violation has not been corrected as of the date of the hearing, ordering that the violation be corrected by a certain date.
- 3. Determine that the violation for which the citation was issued did not occur or that the condition did not constitute a violation of the code.

SECTION 5. Subsection 4906.I. of the Lakewood Municipal Code, regarding "Administrative Order" is hereby amended to read as follows.

I. ADMINISTRATIVE ORDER. The Administrative Hearing Officer shall issue a written decision entitled "Administrative Order" no later than fifteen days after the date on which the administrative hearing concludes. The Administrative Order shall be served upon the responsible person by personal service or by first class mail as provided in Section 4906.C. The Administrative Order shall become final on the date of mailing or other service; it shall notify the responsible person of his or her right to appeal as provided in subsection K of this section. The Administrative Order shall also either (i) set a deadline for compliance with its terms, in the event that the responsible person fails to file an appeal, in no event less than twenty days from the date of mailing, or (ii) if If the hearing officer determines as described in subsection H.2 or H.3 immediately above, and the responsible party has deposited the penalty with the City, the Administrative Order shall order a partial or full refund of the deposit.

SECTION 6. The City Council hereby declarcs it would have passed this Ordinance sentence by sentence, paragraph by paragraph and section by section, and does hereby declare the provisions of this Ordinance are severable, and if for any reason any section of this Ordinance should he held invalid, such decision shall not affect the validity of the remaining parts of this Ordinance.

SUBJECT: AB 2189 (Garcia) Water Replemishment Districts Replemishment Assessment Update

INTRODUCTION

AB 2189, authored by Assembly Member Cristina Garcia, attempts to clarify the process for public notice and majority protest regarding changes in establishing charges related to extraction of groundwater in the Central and West Coast Groundwater Basins. AB 2189 would amend Section 60305 et seq. of the California Water Code which governs the actions of the Water Replenishment District of Southern California (WRD). The WRD is currently in litigation regarding this process.

STATEMENT OF FACT

AB 2189 (Garcia) Water Replenishment districts: replemishment assessment would revise specified provisions to conform the act to Article XIII D of the California Constitution. The bill would require the governing board of each water district to make the specified fludings and determinations before holding the public hearing and would require the board to give written notice by mail to operators of water-producing facilities within the district that would be subject to the proposed replenishment assessment, as specified. By requiring the board to make the specified findings and determinations at an earlier date, this bill would increase the duties of local officials and would impose a statemandated local program. This bill contains other related provisions and other existing laws.

AB 2189 had its first reading before the Committee on Local Government on Wednesday, April 30, 2014. The Local Government Committee voted 5-1 (with 3 members not voting) to pass AB 2189 and referred the bill to the Appropriations Committee. The City opposed the bill as written but offered the following amendments to garner Lakewood's support:

- Change language to clarify the affected parties by removing the reference to water producing facilities and inserting "per acre-foot of water produced" to recognize the volumetric method of imposing the replenishment assessment;
- Include language that excludes the production of stored water exempt from the replenishment assessment pursuant to a court order to recognize that stored water is not subject to the replemishment assessment and therefore should not be weighed for purposes of protests; and
- Delete language regarding the calculation of the replenishment assessment which infers that the cost of potential or future services cannot be included in the assessment to avoid confusion as to permissible funding of long-term projects;

Assembly Committee on Local Government members communicated their concerns about passing legislation that may conflict with ongoing litigation. Assembly Member Garcia made an effort to address those concerns, but it is a point that would benefit from reiteration during review hy the next Committee. To date, the Appropriations Committee has not scheduled a hearing.

SUMMARY

The most recent version of AB 2189 as amended on April 22 does not contain all the changes requested by the Gateway Cities Committee. We understand additional amendments are pending and hope the next amended version will contain all Gateway recommended changes. The Appropriations Committee may hear this bill as early as May 14.

RECOMMENDATION

It is recommended that the City Council direct staff to continue to work with Assembly Member Garcia's staff to incorporate additional amendments to AB 2189 to garner full support and if amended prepare a letter of support from the City Council.
