Regular Meeting held September 13, 2022

MEETING WAS CALLED TO ORDER at 7:30 p.m. by Mayor Croft in the Council Chambers at the Civic Center, 5000 Clark Avenue, Lakewood, California.

Mayor Croft announced that the meeting would be adjourned in memory of former Council Member Joe Esquivel, who passed away on August 24th and had served many years on the City Council and on the Recreation and Community Services Commission as well as being involved in many community volunteer efforts; in memory of Hugh Gillen, the father of Video Operations Specialist, Eileen McIlrath; in memory of Ron Bates, a Los Alamitos council member and a longtime city manager having served in many cities; in memory of Lakewood employee and resident, Sandy Cole, who recently retired after over thirty years of service to the City; and in memory of Griffin Williams, the son of Community Conservation Community Representative, Tony Williams.

The Mayor stated that the 40th Annual Senior Fall Craft Festival would be held on September 24th at the Weingart Senior Center and on the same day, the Public Safety and Emergency Preparedness Expo would be held in the parking lot behind the Civic Center.

Each of the Council Members shared memories and expressed their condolences on the passing of former Council Member Joe Esquivel.

Council Member Chase reported that over the past couple of months, she had attended the League of California Cities and the National League of Cities conferences. She added that she recently had been sworn in as a board member for the League of California Cities Women's Caucus.
