

Minutes Lakewood City Council Regular Meeting held October 25, 2022

**MEETING WAS CALLED TO ORDER** at 7:30 p.m. by Mayor Croft in the Council Chambers at the Civic Center, 5000 Clark Avenue, Lakewood, California.

## **ANNOUNCEMENTS AND PRESENTATIONS:**

Mayor Croft announced that the meeting would be adjourned in memory of Jesus Diaz, father-in-law of Vice Mayor Ariel Pe; in memory of Duane Soileau, who was a longtime public works contractor for the City; and in memory of Maisie Pan, the mother of Bill Pan, contract Senior IT Specialist.

The Mayor introduced Diana Craighead, Vice President of the Long Beach Unified School District Board of Education, who made a presentation regarding the Dual Immersion Program and provided an update on facilities.

Mayor Croft presented, on behalf of the City Council, a proclamation to the Southeast County Young Marines regarding Red Ribbon Week, when Lakewood joined with local schools and others to encourage and show support for a drug-free lifestyle.

Mayor Croft introduced Sheriff's Station Commander, Captain Dan Holguin, who provided the Quarterly Public Safety Report. Captain Holguin reported on Part I crimes, Special Assignment deputies and City-supported crime suppression efforts; collaboration with the City's Public Safety team, crime prevention, mall security, and homeless community services and assistance. He acknowledged support for creating racial equity stating that he would make every effort to build stronger community relations and trust with Lakewood residents. He thanked the Public Safety team for the continued leadership, partnership, and support in providing Lakewood Station with the necessary resources to best serve Lakewood.

# 3.3 • AGREEMENT WITH CITY OF LONG BEACH BOARD OF WATER COMMISSIONERS FOR DESIGN, CONSTRUCTION AND OPERATION OF A SECOND INTERCONNECTION

Derek Nguyen, Director of Water Resources, displayed slides and made a presentation based on the report in the agenda pertaining to the construction of an emergency interconnection at the intersection of Carson Street and Palo Verde Avenue in Long Beach. He concluded by stating it was staff's recommendation that the City Council approve the agreement with the Board of Water Commissioners of the City of Long Beach for design, construction, and operation of a second interconnection; and authorize its execution by the Mayor on behalf of the City.
