### **INTRODUCTION**

### **STATEMENT OF FACTS**


The City has utilized the banking services of Bank of America for over many years. Switching banks had become difficult due to the functionality that is required by cities. Recently, this has changed and many banks can offer the level of service we require. Additionally, Bank of America fees have escalated to where they are no longer competitive as compared to other banks, and their customer service office have become regionalized.

Farmers & Merchants Bank provided the Administrative Services Department a banking proposal that meets the electronic and functionality requirements of the City, provides a local branch for the City's customer service needs, and offers a fee schedule that will result in an annual savings of \$43,000.

The transition to Farmers & Merchant Bank will be a two to three month process. Administrative Services staff will work with Public Information staff to inform our employees, vendors and utility customers of the change.

### **STAFF RECOMMENDATION**

It is recommended that the Council approve the Account Agreement with Farmers and Merchants Bank, and authorize the Mayor, City Manager and Director of Administrative Services to sign the documents necessary to effectuate the transition.

**SUBJECT:** Resolutions for the 2017 General Municipal Election

### **INTRODUCTION**

In accordance with Section 1500 of the Lakewood Municipal Code, the municipal election shall be held on the first Tuesday after the first Monday in March of odd-numbered years. The date for the 2017 Election will be March 7th.

### **STATEMENT OF FACTS**

Lakewood's General Municipal Election will be held on March 7, 2017, to select three members of the City Council for terms of four years. Registered voters of the City interested in running for this office must complete the nomination process prescribed by State election law. The nomination period will be open over a four-week period beginning on Monday, November 14th and concluding on Friday, December 9th.

The Registrar-Recorder/County Clerk has notified the City of Lakewood that the Los Angeles County Board of Supervisors is expected to call for a Special Countywide Election on March 7, 2017, to place before voters a ballot measure to address homelessness and other issues. The County has until December 9th to decide if they will do so leaving cities with the option to either consolidate the General Municipal Election with the Special Countywide Election or to conduct a concurrent election. To minimize voter confusion associated with concurrent elections, the County Registrar is encouraging cities to consolidate their elections with the Special Countywide Election.

This is the first time that cities with elections in March of odd-numbered years have been given the option to consolidate with the County. Consolidating the City's election with the County would mean that the County Registrar would administer, manage, and oversee many facets of the City's election, including services and tasks related to the complete and successful conduct of the election; provision of all election materials and equipment; the hiring, training and supervision of poll workers; printing and distribution of ballot materials; the tallying of votes; and canvassing of election results. The City Clerk's Office would continue to handle the candidate nomination filing process, FPPC filings and publishing of official election notices relating to calling an election and nominations. Ballot counting would take place at the County Registrar's office and semi-official election results may not be available on election night. Additionally, the County Registrar has up to 28 days to complete the official canvass, and this will likely cause a delay in certification of the election, swearing in of Council Members and reorganization.

The amount budgeted for a standalone election is \$127,000 based on estimates provided by the City's elections consultant, Martin & Chapman Company. The County Registrar provided the City with an estimated cost of \$94,227.47 for election services of a consolidated election.

Lakewood has a history of standalone elections; however, the City may not have the option to run a standalone election if Martin & Chapman Company goes out of business due to cities consolidating their elections with the County. The Martin & Chapman Company, located in the city of Anaheim, has been providing election consulting services and election supplies to the City of Lakewood for more than 45 years. They are also the sole provider of the Optomark voting system utilized for ballot counting during the City's General Municipal Election.


If the County does not call the Special Countywide Election to be held on March 7, 2017, to place a measure on the ballot, the City can opt to conduct its own standalone election at which time the Board of Supervisors would be requested to permit the Election Department to prepare and furnish specified services in conducting the election.


In accordance with requirements as set forth in the Elections Code, the City Council must adopt certain resolutions in a timely manner pertaining to General Municipal Elections. The following resolutions are presented for consideration at this time:

1. Resolution Calling and Giving Notice of the Election;
2. Resolution Requesting the Board of Supervisors of Los Angeles County to Render Specified Election Services;

**STAFF RECOMMENDATION**

Staff recommends that the City Council adopt the attached resolutions pertaining to the General Municipal Election on March 7, 2017, and authorize retention of Martin & Chapman Company for election services and supplies.

RESOLUTION NO. 2016-62

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LAKEWOOD, CALIFORNIA, CALLING AND GIVING NOTICE FOR THE HOLDING OF A GENERAL MUNICIPAL ELECTION TO BE HELD IN SAID CITY ON TUESDAY, MARCH 7, 2017, FOR THE ELECTION OF CERTAIN OFFICERS OF SAID CITY AS REQUIRED BY THE PROVISIONS OF THE LAWS OF THE STATE OF CALIFORNIA PERTAINING TO GENERAL LAW CITIES

WHEREAS, under the provisions of the laws relating to general law cities of the State of California, a General Municipal Election shall be held on Tuesday, March 7, 2017, for the election of three Members of the City Council of the City of Lakewood for the full term of four years; and

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF LAKEWOOD, DOES HEREBY RESOLVE AS FOLLOWS:

SECTION 1. That pursuant to the requirements of the laws of the State of California relating to general law cities, there is called and ordered to be held in the City of Lakewood, California, on Tuesday, March 7, 2017, a General Municipal Election for the purpose of electing three Members of the City Council for the full term of four years.

SECTION 2. That the ballots to be used at said election shall be in form and content as required by law.

SECTION 3. That the City Clerk of said City is hereby authorized, instructed and directed to procure and furnish any and all official ballots, notices, printed matter and all supplies, equipment, and paraphernalia that may be necessary in order to properly and lawfully conduct said election.

SECTION 4. That pursuant to Elections Code §10242, the polls for said election shall be open at seven o'clock a.m. on the day of said election and shall remain open continuously from that time until eight o'clock p.m. of the same day when said polls shall be closed, except as provided in Section 14401 of the Elections Code of the State of California.

SECTION 5. That pursuant to Section 13307 of the Elections Code of the State of California, each candidate for elective office to be voted for at the General Municipal Election to be held in the City of Lakewood on March 7, 2017, may prepare a candidate's statement on an appropriate form provided by the City Clerk. Such statement may include the name, age and occupation of the candidate and a brief description of no more than 200 words of the candidate's education and qualifications expressed by the candidate himself or herself. Such statement shall not include party affiliation of the candidate, nor membership or activity in partisan political

organizations. Such statement shall be filed, in typewritten form, in the office of the City Clerk at the time the candidate's nomination papers are filed. Such statement may be withdrawn, but not changed, during the period for filing nomination papers and until 5:00 p.m. of the next working day after the close of the nomination period.

SECTION 6. Pursuant to the Federal Voting Rights Act, the City is required to translate candidates' statements into the applicable languages, in addition to providing it in English. The main voter pamphlet will be printed in English and Spanish, with required language translations of candidates' statements printed in a facsimile voter pamphlet. The City Clerk shall have all translations made available upon request in the Office of the City Clerk. Additionally, in accordance with State law, a candidate's statement must be translated and printed in any language at the candidate's request.

SECTION 7. The candidates shall be required to pay for the cost of translating and printing their candidates' statements into any required foreign language pursuant to Federal and/or State law, as specified, and into any other foreign language requested by the candidate.

The City Clerk shall estimate the total cost of printing, handling, translating and mailing the candidates' statements filed pursuant to this section, including costs incurred as a result of complying with the Voting Rights Act of 1965 (as amended), and require each candidate filing a statement to pay in advance to the local agency his or her estimated pro rata share, as a condition of having his or her statement included in the voter's pamphlet. The estimate is an approximation of the actual cost that varies from one election to another election and may be significantly more or less than the estimate, depending on the actual number of candidates filing statements. Accordingly, the City Clerk is not bound by the estimate and may, on a pro rata basis, bill the candidate for additional actual expense or refund any excess paid depending on the final actual cost. In the event of underpayment, the City Clerk shall require the candidate to pay the balance of the cost incurred and said candidate shall pay the same within thirty (30) days of being so billed. In the event of overpayment, the City Clerk shall prorate the excess amount among the candidates and refund the excess amount paid within thirty (30) days of the election.

SECTION 8. If the City conducts its own standalone election, pursuant to Elections Code §12310, a stipend for services for the persons named as precinct board members is fixed at the sum of \$200 for each Inspector and \$150 for each Clerk for the election. The rental for each polling place, where a charge is made, shall be the sum of \$50 for the election.

SECTION 9. That in all particulars not recited in this Resolution, said election shall be held and conducted as provided by law for holding municipal elections in said City.

SECTION 10. That notice of the time and place of holding said election is hereby given and the City Clerk is hereby authorized, instructed and directed to give such further or additional notice of said election, in time, form and manner as required by law.

SECTION 11. The City Clerk shall certify to the adoption of this Resolution and shall make a minute of passage and adoption thereof in the City of Lakewood, in the minutes of the meeting at which the same is passed and adopted.

RESOLUTION NO. 2016-63

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LAKEWOOD, CALIFORNIA, REQUESTING THE BOARD OF SUPERVISORS OF THE COUNTY OF LOS ANGELES TO RENDER SPECIFIED SERVICES TO THE CITY RELATING TO THE CONDUCT OF A GENERAL MUNICIPAL ELECTION TO BE HELD ON TUESDAY, MARCH 7, 2017

WHEREAS, a General Municipal Election is to be held in the City of Lakewood, California, on March 7, 2017; and

WHEREAS, in the course of conduct of the election it is necessary for the City to request services of the County of Los Angeles; and

WHEREAS, all necessary expenses in performing these services shall be paid by the City of Lakewood; and

WHEREAS, there may also be a countywide special election held on March 7, 2017, and the City of Lakewood has decided that it will consolidate with the County of Los Angeles if there is such an election.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF LAKEWOOD, CALIFORNIA, DOES HEREBY RESOLVE AS FOLLOWS:

SECTION 1. If there is a countywide special election held on March 7, 2017:

A. City will consolidate with the County

(1) That pursuant to the requirements of § 10403 of the Elections Code, the Board of Supervisors of the County of Los Angeles is hereby requested to consent and agree to the consolidation of a General Municipal Election with the countywide special election on Tuesday, March 7, 2017, for the purpose of the election of three Members of the City Council.

(2) That the City of Lakewood will print and mail its own Voter Information Guide to the voters of the city.

(3) That the county election department is authorized to canvass the returns of the General Municipal Election. The election shall be held in all respects as if there were only one election, and only one form of ballot shall be used. The election will be held and conducted in accordance with the provisions of law regulating the special election.

SECTION 2. If there is not a countywide special election held on March 7, 2017:

A. City will conduct its own standalone election

(1) That pursuant to § 1301 of the Elections Code the City of Lakewood desires to conduct its own election.

(2) That pursuant to the provisions of § 10002 of the Elections Code of the State of California, this City Council requests the Board of Supervisors of the County to permit the County Election Department to prepare and furnish the following for use in conducting the election:

- a. A listing of county precincts with number of registered voters in each, so city may consolidate election precincts into city voting precincts, and maps of the voting precincts;
- b. A list of polling places and poll workers the county uses for their elections;
- c. The voter record of the names and address of all eligible registered voters in the City in order that the City's consultant may:
  - i. Produce labels for vote-by-mail voters;
  - ii. Produce labels for voter information guides;
  - iii. Print Rosters of Voters and Street Indexes;
- d. Voter signature verification services as needed and voter signature files as needed;
- e. Make available to the City election equipment and assistance as needed according to state law.

SECTION 3. That the City shall reimburse the County for services performed when the work is completed and upon presentation to the City of a properly approved bill.

SECTION 4. That the City Clerk is directed to forward without delay to the Board of Supervisors and to the County Election Department, each a certified copy of this resolution.

SECTION 5. That the Board of Supervisors is requested to issue instructions to the county election department to take any and all steps necessary for the holding of the consolidated election.

SECTION 6. That the City Clerk shall certify to the passage and adoption of this Resolution and enter it into the book of original Resolutions.

**SUBJECT:** Proposition 57 – Public Safety and Rehabilitation Act of 2016

### **INTRODUCTION**

Proposition 57 would increase parole chances for felons convicted of “non-violent crimes” and give them more opportunities to earn credits for good behavior. It would also allow judges, not prosecutors, to decide whether to try certain juveniles as adults in court. The proposition qualified for the ballot when Governor Jerry Brown added his plan to overhaul the rules regarding parole eligibility for inmates serving time for non-violent crimes to a proposed ballot initiative that was already being vetted and dealt solely with juvenile justice. In June 2016, the Supreme Court upheld this action and overturned the lower court ruling that initially blocked the measure. On October 6, 2016 the League of California Cities established an oppose position on Proposition 57.

### **STATEMENT OF FACT**

This measure would make changes to the State Constitution to increase the number of inmates eligible for parole consideration and provide the California Department of Corrections and Rehabilitation (CDCR) with additional authority to award credits to inmates. The measure also would make statutory changes to require that youths have a hearing in juvenile delinquency court before they can be transferred to adult criminal court.

Parole Consideration for Non-Violent Offenders – Proposition 57 amends the State Constitution to specify that any person convicted of a non-violent felony offense and sentenced to state prison shall be eligible for parole consideration after completing the full-term for his or her primary offense. The measure defines primary offense as the longest term imposed excluding any additional terms that are added to an offender’s sentence. Additional terms include: 1) the sentences for the lesser crimes the inmate is convicted of and 2) sentencing enhancements (such as the additional time an inmate must serve for using a firearm while committing a crime). As a result, these offenders could be released early, after serving the term for their primary offense. In addition, the measure authorizes CDCR to adopt regulations to implement the above changes and requires the Secretary of CDCR to certify that they protect and enhance public safety.

Authority to Award Credits – The measure also amends the State Constitution to specify that CDCR shall have the authority to award credits to inmates for good behavior and approved rehabilitative or educational achievements. As a result, CDCR could authorize credits beyond the current limits. In addition, the measure authorizes CDCR to adopt regulations to implement

the above changes and requires the Secretary of CDCR to certify that they protect and enhance public safety.

Juvenile Transfer Hearings – This measure modifies status regarding fitness hearings to require that all youths have a hearing in juvenile delinquency court before they can be transferred to adult criminal court. As a result, prosecutors would no longer be able to file charges directly in adult criminal court and no youths would have their cases heard in adult criminal court on a mandatory basis. In addition, the measure specifies that hearings to transfer youths to adult criminal court could only be sought for 1) youths accused of committing certain major crimes specified in statute (murder, robbery, and certain sex offenses) when they were age 14 or 15 and 2) youths accused of committing a felony when they were aged 16 or older. As a result, there may be fewer youths tried in adult court. These youths would likely be subject to shorter terms than would be the case were they subject to adult sentences.

**Issues:**

The California District Attorneys Association (CDAА) has been the primary opponent of Proposition 57, arguing that the language introduces drastic changes to sentencing laws, including eligibility for parole that disregards enhancements such as use of a deadly weapon, commission of a crime to benefit a criminal street gang, or prior prison terms; disregards consecutive sentences for the commission of multiple offenses; and provides prison officials with broad authority to award increased conduct credits, including to murderers and rapists.

According to the CDAА, the measure would significantly undermine more than 40 years of criminal justice policies approved by the Legislature and California voters that were designed to enhance public safety and protect crime victims' rights. The proposal conflicts with other constitutional and legislative provisions, including the use of enhancements mandated by The Victims' Bill of Rights (Proposition 8), the truth-in-sentencing provisions of Marsy's Law, the treatment of serious juvenile offenders provided in Proposition 21, human trafficking law, and the Three Strikes law.

The CDAА has identified impacts that are contained in the proposal's provisions. While these impacts maybe unintended, they may be likely raised by criminal defendants and accepted by the courts.

1. Inmates sentenced to non-violent felony offenses will be eligible for parole consideration after completion of only the term of their primary offense. This will include crimes designated by the Legislature and the voters as "serious" offenses.
2. All enhancements will be excluded from the full term of the primary offense, including enhancements for use of a deadly weapon, excessive taking of property and commission of a crime while on bail, gang enhancements, prior prison terms, prior serious or violent felonies, etc. Defendants whose sentences were increased for these enhancements will be eligible for parole at the same time as defendants who do not have any enhancements.

3. Consecutive sentences will be excluded from the full term of the primary offense. Felons who commit multiple crimes against multiple victims will be eligible for early release at the same time as inmates who commit only one crime against one victim.
4. "Alternative sentences" involving increased punishment like the Three Strikes law will be excluded from the full term of the primary offense for many offenders. Thus, repeat serious and violent offenders will be eligible for early release at the same time as inmates who have no criminal histories.
5. The measure will give CDCR unilateral and unlimited authority to award credits to all inmates, regardless of their charges or sentences, for good behavior and approved rehabilitative or educational achievements.
6. The measure eliminates the ability of prosecutors to directly file in adult court serious and violent crimes committed by the most dangerous juvenile offenders, including gang members just shy of their 18<sup>th</sup> birthday. The measure also eliminates the presumption that minors charged with enumerated serious crimes should be tried in adult court.

**Possible additional consequences:**

1. Based on wording of the proposed constitutional provision, an argument can be made that every inmate with at least one non-violent felony conviction is eligible for early release, regardless of whether the inmate has additional convictions that are violent.
2. The courts may hold that, based upon equal protection principles, county jail inmates sentenced under Penal Code section 1170(h), and also defendants eligible for post-release Community Supervision, are entitled to the benefit of the new provisions.
3. Most inmates serve only half of their sentences. It is likely that the provisions regarding credits and adoption of regulations would permit CDCR to provide additional credits in excess of the limitations contained in the Penal Code.
4. As with Proposition 47, this measure does not implement services or care for those paroled. Without jobs, homes, or services for substance abuse, increased crime could certainly be an additional consequence.

**Fiscal Impact:**

This measure would have various fiscal effects on the state and local governments. However, the extent of these costs would depend on how certain provisions in the measure are interpreted and implemented, such as the extent to which Board of Parole Hearing (BPH) grants parole and CDCR awards additional credits. The Legislative Analyst's Office (LAO) estimates the following:

- Net state savings that could range from the tens of millions of dollars to the low hundreds of millions of dollars annually, primarily due to the reduction in the prison population from additional paroles granted and credits earned.
- Net county costs that could range from the millions to tens of millions of dollars annually, declining to a few million dollars after initial implementation of the measure.
- No estimate of the costs to local governments for possible increased crime was done by the LAO.
- No estimate of the costs to victims of crime was done by the LAO.

**RECOMMENDATION**

That the City Council join the League of California Cities and adopt the attached Resolution, opposing Proposition 57 – the Public Safety and Rehabilitation Act of 2016.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF  
LAKEWOOD DECLARING OPPOSITION TO PROPOSITION  
57 – THE PUBLIC SAFETY AND REHABILITATION ACT OF  
2016

THE CITY COUNCIL OF THE CITY OF LAKEWOOD DOES RESOLVE AS FOLLOWS:

WHEREAS, the City of Lakewood has placed a high priority of ensuring the safety and quality of life for its citizens; and

WHEREAS, the City of Lakewood believes it is appropriate to oppose actions or initiatives at local, state and federal levels that could jeopardize the safety of its citizens; and

WHEREAS, Proposition 57, known as the Public Safety and Rehabilitation Act of 2016, has qualified for the November 8, 2016 General Election ballot; and

WHEREAS, the title of the initiative is designed to garner public support, but is misleading and does not reflect its actual provisions to release repeat offenders and other prisoners earlier than allowed by current law endangers, rather than protects, public safety; and

WHEREAS, the stated purpose of the initiative is to “improve rehabilitation” and the proposal allows credits for “approved rehabilitative or educational improvements,” but the proposal provides no funds or any other provisions to develop or expand rehabilitative programs; and

WHEREAS, the initiative contains the exclusion of enhancements, consecutive sentences, and alternative sentences contrary to longstanding existing law and principles in California law, including Proposition 8 (The Victims’ Bill of Rights) approved by voters in 1982, Proposition 9 (Marsy’s Law), Proposition 21 (The Gang Violence and Juvenile Crime Prevention Act of 1998), among others, and

WHEREAS, notwithstanding the objectives of Proposition 57, California has experienced increased and sustained property crime in the aftermath of the 2011 public safety realignment and the passage of Proposition 47 in 2014, leading to an increasing number of crimes being treated as misdemeanors, aggravating a pre-existing shortage of beds in county jails, and resulting in an increasing number of offenders being at liberty on the streets of California’s cities; and

WHEREAS, according to the Los Angeles Times, violent crime in California rose in by 10 percent in 2015, a figure corroborated by crime statistics maintained by the California



Department of Justice, which indicate that over 15,000 more violent crimes occurred in California in 2015 than in 2014; and

WHEREAS, Proposition 57 would potentially lead to early release for offenders convicted of “non-violent crimes,” many of which seem more properly categorized as violent, including throwing acid with the intent to disfigure, and discharging a firearm from a motor vehicle, to name a few, and this triggers concerns that offenders which committed offenses widely regarded as violent will be provided undue leniency; and

WHEREAS, Proposition 57 could increase the likelihood of parole for persons convicted of “non-violent” felonies after completing the full term for his or her primary offense, and by disqualifying earned enhancements; and

WHEREAS, the passage of Proposition 57 may result in undetermined but negative consequences to public safety and well-being for California’s cities and residents,

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF LAKEWOOD does hereby resolve as follows:

Section 1: THE CITY COUNCIL OF THE CITY OF LAKEWOOD opposes Proposition 57

Section 2: THE CITY COUNCIL OF THE CITY OF LAKEWOOD will join the “No on 57” Coalition.

**SUBJECT:** Resolution Supporting Accountability in Criminal Prosecution and Sentencing

### **INTRODUCTION**

After decades of historic lows, crime is increasing in California communities, including Lakewood. The trend in the state is to protect perpetrators of crime instead of the victims of their crimes. It is important to support and defend the public and our deputy sheriffs and police officers and hold perpetrators of crime accountable for their actions.

### **STATEMENT OF FACT**

The public safety realignment of 2011/12 released 58,746 inmates from state prison. Proposition 47 in 2014 downgraded more crimes as misdemeanors which resulted in increasing numbers of offenders staying on city streets instead of being prosecuted and imprisoned. After the implementation of AB 109 and Proposition 47 the state of California experienced 15,000 more violent crimes in 2015 than in 2014. California Department of Justice statistics show an increase in violent crime of 10 percent in 2015.

The upcoming ballot measure Proposition 57 would make changes to the State Constitution to increase the number of inmates eligible for parole consideration and would also result in still higher numbers of offenders on city streets. The California District Attorneys Association (CDA) has been the primary opponent of Proposition 57, arguing that the language introduces drastic changes to sentencing laws, including eligibility for parole that disregards enhancements such as use of a deadly weapon, commission of a crime to benefit a criminal street gang, or prior prison terms; disregards consecutive sentences for the commission of multiple offenses; and provides prison officials with broad authority to award increased conduct credits, including to murderers and rapists.


There is also a disturbing trend toward offenders attacking and killing law enforcement personnel. In the past five years 52 peace officers in California have been killed in the line of duty – half by gunfire.


The effects of decriminalization are dangerous and statewide. To improve this situation the following actions are required: support and defend victims of all crimes; support and defend law enforcement personnel; provide accountability and incentive for rehabilitation for non-violent criminals and drug offenders; to research and deal with the causes of increasing populations of the mentally ill and homeless; and account for the actual cost of decriminalization measures including increased victimization and negative impacts upon neighborhoods. The Public Safety

Committee has reviewed the facts/data and believes that for maximum effectiveness, the City should work in cooperation with the California Contract Cities Association, the League of California Cities, and other cities and legislators.

**RECOMMENDATION**

That the City Council adopt the proposed resolution declaring support for accountability in criminal prosecution and sentencing in the State of California and direct staff to explore opportunities to promote objectives through a public safety summit, developing legislation and coordinating law enforcement appreciation efforts.

THE CITY COUNCIL OF THE CITY OF LAKEWOOD DOES RESOLVE AS FOLLOWS:

WHEREAS, the City of Lakewood places a high priority on ensuring the safety and quality of life for its citizens; and

WHEREAS, the City of Lakewood believes it is appropriate to support actions at local, state and federal levels that could ensure the safety of its citizens; and

WHEREAS, the City of Lakewood values the service provided by law enforcement personnel, and is concerned about increasing threats to their lives and safety knowing that in California in the past five years 51 peace officers have been killed in the line of duty, and half of those deaths were by gunfire; and

WHEREAS, nationwide gunfire deaths of law enforcement personnel increased by 57 percent this year; and

WHEREAS, the public safety realignment of 2011/12 resulted in the transfer of 58,746 inmates from prison to county jails, and along with Proposition 47 in 2014, which implemented prosecution and sentencing reductions, resulted in large numbers of offenders released onto city streets who would previously have served sentences for the crimes they committed; and

WHEREAS, the City of Lakewood is concerned about increasing crime rates in the city and in the state which experienced a ten percent increase in violent crimes in 2015 after decades of historic lows; and

WHEREAS, Proposition 57, known as the Public Safety and Rehabilitation Act of 2016, has qualified for the November 8, 2016 General Election ballot, and its provisions to release repeat offenders and other prisoners earlier than allowed by current law endangers, rather than protects, public safety; and

WHEREAS, the City of Lakewood believes that victims of crime need protection and program assistance, and that actions to reduce crime are essential; and

WHEREAS, this is a statewide issue requiring a statewide solution, the City will seek support of the California Contract Cities Association (CCCA) and the League of California Cities to effect the following improvements: to support and defend victims of all crimes, to

support and defend our deputy sheriffs and police officers; to provide accountability and incentive for rehabilitation for non-violent criminals and drug offenders; to research and deal with the causes of increasing populations of the mentally ill and homeless; and account for the actual cost of decriminalization measures including increased victimization and negative impacts upon neighborhoods; and

WHEREAS, the County of Los Angeles is considering approval of the construction of a new correctional facility replacing the men's central jail with one thousand fewer beds than their consultant says will be needed by the time it opens in seven to eight years.

NOW, THEREFORE, BE IT RESOLVED THAT THE CITY COUNCIL OF THE CITY OF LAKEWOOD does hereby declare its support for accountability in criminal prosecution and sentencing in the State of California.

**SUBJECT:** Adaptive Recreation/Special Olympics Annual Report

### **INTRODUCTION**

The City of Lakewood serves the needs of intellectually, developmentally, and physically disabled individuals through the Adaptive Recreation and Special Olympics programs. Over the years, these two programs have steadily grown, making a difference in the lives of the participants. The main objective of these programs is to provide equal recreation and leisure opportunities for people with special needs. In 2017, the Lakewood Special Olympics program will celebrate its 25<sup>th</sup> anniversary and the Adaptive Recreation program will be operating in its 36<sup>th</sup> year. Each year, these programs grow with a variety of fresh programming and first-class athletic opportunities, providing participants with healthy, athletic and social outlets and mainstream inclusion.

### **ADAPTIVE RECREATION**

The Adaptive Recreation program is facilitated at Palms Park, once a week on Tuesdays. Recreation staff helps develop social and independent living skills, through various activities for the clients. Special weekend events are also coordinated throughout the year and held at Bloomfield Park. Events include four themed dances, a talent show, and several other special events. This year, five special events including the popular Talent Show, drew 175 clients while the dances brought in a record 206 participants. The dances are held in the activity room and offer games and contests, a snack bar, a backdrop station for pictures, a staff DJ playing current pop music, and access to the Adaptive Clubhouse at the north end of the main building. The Adaptive Clubhouse plays a big role in these events. This space is exclusive to Adaptive Recreation and Special Olympics participants. Its many amenities create a comfortable environment for the participants. The clubhouse has been a source of pride for participants to enjoy.

### **SPECIAL OLYMPICS**

The Lakewood Special Olympics program, which already demonstrates high participation, saw more growth in 2016. With diminishing participation in the fall sport of tennis, the more popular sport of bowling was petitioned for at the end of 2015. In early 2016, Special Olympics Southern California (SOSC) granted Lakewood their first bowling squad to take the place of a tennis team. The bowling team, similar to the golf program, is coached entirely by volunteers. After SOSC staff formed a partnership with Cal Bowl Bowling Alley in Lakewood, the new team had a regular home for practices. Practices began in August when the new training season began, and take place on Tuesdays from 6:30 to 7:30 p.m. Four new volunteer coaches have been certified to lead the team, and the inaugural unit consists of 16 athletes who have chosen

bowling as their primary sport of competition. Bowling joins softball and soccer as the third fall/winter sport in which Lakewood will compete. The Lakewood bowling team goes by the name "Split Happens."

Lakewood Special Olympics saw growth in numbers as well. The roster of participants increased to 113 registered active athletes in 2016. These athletes comprise the rosters of the six Lakewood sports which include basketball, bocce, and golf in the spring/summer season, and softball, soccer, and bowling, in the fall/winter season. The program has several teams in each of these sports, which participate in different divisions based on ability. Lakewood Special Olympics sent teams to participate in a total of 18 tournaments in 2016.

The Lakewood teams are trained well by the staff and volunteer coaches, and are always competitive. The men's high division basketball team, the women's basketball team, and one unified golf team qualified for the annual Special Olympics Southern California (SOSC) Summer Games in June at Long Beach State University. Twenty athletes made the trip along with seven coaches. At the end of the weekend, the Lakewood 49ers won the gold medal for basketball in the men's high division. The Lady Aliens women's basketball team won the bronze medal in their tournament. These efforts ensured that all but one Lakewood athlete medaled at the games.

Three Lakewood teams have qualified for the 2016 SOSC Fall Games. Lakewood will send one softball team and one soccer team to the championships to be held on November 12 and 13 in Fountain Valley. One Lakewood bowling team will participate in the championships on December 4<sup>th</sup> in Fountain Valley.

Lakewood's staff, volunteers and athletes in the Special Olympics program continue to be recognized and celebrated for their leadership and achievements in the Special Olympics community.

- At the 2016 Lakewood Hall of Fame Awards Banquet, Lakewood athlete Naveed Manjra won the Lakewood Special Olympics Athlete of the Year Award. Naveed won the Gold Medal for the high level golf competition at the 2015 Summer Games.
- In April, Long Beach City College recognized Community Services Supervisor, Chuck Martucci with the Alumni of the Year Award for his achievements in working with those with developmental disabilities over the course of his career in the City of Lakewood.

## **RECOMMENDATION**

Staff recommends that the Mayor and City Council receive and file the report.

**SUBJECT:** Preliminary Engineering Design Services – Lakewood Blvd Regional Corridor Capacity Enhancement Project

### INTRODUCTION

The Los Angeles County Metropolitan Transportation Authority (LACMTA) has provided a grant of \$3,600,000 in Measure R Funds for improvements to Lakewood Boulevard within the City of Lakewood as part of the Lakewood Boulevard Regional Corridor Capacity Enhancement Project.

### STATEMENT OF FACT

At its regular meeting on August 9, 2016, the City Council approved a Funding Agreement with Los Angeles County Metropolitan Transportation Authority that designates \$3,600,000 in Measure R Funds for Design, Plans, Specifications and Estimates and Project Development for improvements to Lakewood Boulevard from Del Amo Boulevard to the city limits north of Ashworth Street. These funds come from LACMTA share of Measure R and are not the local return that is allocated to the City of Lakewood. There will be a future funding agreement for the construction phase.


The project includes street widening, median improvements, bike lanes, sidewalk, street resurfacing, ADA and storm water compliance, traffic signal modification, drought-resistant landscaping and irrigation and signing and striping; all within the existing right-of-way. Final Plans and Specifications are scheduled to be complete at the end of 2017.

The consulting engineering firm of Willdan has an agreement with the City of Lakewood to assist with various engineering matters. Willdan has provided a proposal for preliminary engineering design services for this project in an amount of \$678,185.

### RECOMMENDATION

That the City Council authorize staff to approve Willdan's proposal to provide preliminary engineering design services for the Lakewood Blvd Regional Corridor Capacity Enhancement Project in an amount of \$678,185.
