SUBJECT: Report of City Council Committees' Activities

INTRODUCTION

A brief update is provided for City Council review on the activities of the following standing committees: Audit and Water Resources committees.

STATEMENT OF FACT

On March 10, 2022, the Audit Committee met and discussed:

Staff and Suzanne Harrell (Financial Advisor - Director, Harrell & Company) presented a draft of the proposed Unfunded Accrued Liability Funding Policy. The purpose of the policy is to accelerate the payoff of the city's unfunded accrued liabilities related to PERS. The proposed policy establishes a Pension Section 115 Trust and allows for the use of additional discretionary payments to better manage their budgetary impact while reducing their long-term costs to the city. In shifting current reserve funds into a Section 115 Trust, it requires that the city's current Governmental Fund Balance Policy be modified by eliminating the need to maintain pension obligations funds in the city's reserves. There were additional slight changes proposed to the fund balance policy, including the creation of two new categories, the Capital Improvement Contingency, and Long-Term Obligations designations.

Lastly, staff presented a revised Purchasing Policy with the primary revision being the addition of a local vendor provision. It allows the amounts the city receives in Bradley-Burns and Measure L sales tax revenues from a local purchase to be taken into consideration when evaluating and awarding a bid. It also includes minor revisions regarding the disposition of surplus supplies and equipment, petty cash approvals, and formally incorporates the new California Uniform Public Construction Cost Accounting Act (CUPCAA) provisions adopted by the City Council into the Public Works Projects section of the policy.

On March 15, 2022, the Water Resources Committee met and discussed:

Water Capital Improvement Program (CIP) Projects Update

- Well 28 - Due to delay in pump and motor parts, operation of well is anticipated in May.
- Plant 13 - Contractor submitted Notice of Completion for Phase I, only one item remains on the punch-list. Phase II design bid packet planned to go out next week.
- Well 15A Rehab - Delivery of pump and motor part expected this Friday; installation will be scheduled thereafter.

Water Supply and Water Rights Update

Water supply, sales and demand statistics were updated with February numbers. Water delivery to Long Beach has been shut down due to scheduled repairs on their side. Decreases seen were

included in previous projections, no major production changes are expected. Lakewood has proposed a change to WRD's carryover calculation; the proposed rule change would allow water utilities to store all unused water rights. The Water Rights Panel will schedule a special meeting in June to vote on the rule change. Staff will continue efforts of leasing water rights as a back-up.

Utility Billing and Customer Service – Monthly Update


Posting of credits from the COVID Arrearages Program have been completed. Prop 218 notices regarding increase of trash rates scheduled to go out this week as a billing insert, notices to be completed within a 45-day timeframe. Notices of outstanding balances to go out during April and May reminding customers COVID protection expired. SB 998 notices will be sent end of May to early June, notices for partial collection of finalized accounts in June and July, and shut offs to commence July to August. Call statistics showed average wait times are under a minute. The three-year agreements with multiple utility billing vendors expires December 2022, staff is in the process of communicating to each regarding contract extensions. Staff found that the amount of undelivered bills in the beginning of January, due to delay on part of the Post Office, weren't as high as initially thought and staff continues to promote online billing.

Oral Communications

- Well 22 water quality sampling schedule will change from tri-annual to quarterly.
- Sanitary Survey, conducted by State Board's Division of Drinking Water, occurs every 3 years, identified minor issues which a number of have already been resolved. Some of the items, like the removal of below ground tanks, will be integrated as part of upcoming CIP projects.
- On March 1 at 2 a.m., a car hit Metropolitan's control panel that controls the emergency connection to the Lakewood water system located on the corner of Industry and Cover. MET will repair as impacted equipment is theirs.
- WRD's redistricting map went from five to four areas, Lakewood remains in Division 4 whereas the cities of Norwalk and La Mirada were added.
- Water Resources staff has revamped its Water Awareness bookmark contest that now includes utilization of the online Water Portal. The program is due to be piloted at MacArthur Elementary in the coming weeks.

INVESTMENT GLOSSARY

ABS (Asset-Backed Securities)

A mortgage pass-through security, collateralized mortgage obligation, mortgage-backed or other pay-through bond, equipment lease-backed certificate, consumer receivable pass-through certificate, or consumer receivable-backed bond.

AGENCY (U.S. Government Agency Issues)

Federal agency or United States government-sponsored enterprise obligations, participations, or other instruments, including those issued by or fully guaranteed as to principal and interest by federal agencies or United States government-sponsored enterprises. There are no portfolio percentage limits for U. S. Government Agency issues.

BOND (Municipal Bonds or Note)

Registered treasury notes or bonds issued by states or municipalities, including bonds payable solely out of the revenues from a revenue-producing property owned, controlled, or operated by a state or by a department, board, agency, or authority of any of the other 49 United States, in addition to California.

CAMP (California Asset Management Program)

A Joint Powers Authority established in 1989 by the treasurers and finance directors of several California public agencies to provide an investment pool at a reasonable cost. Participation is limited to California public agencies.

CD (Certificate of Deposit)

Negotiable CDs are issued by large banks and are freely traded in secondary markets as short term (2 to 52 weeks), large denomination (\$100,000 minimum) CDs, that are either issued at a discount on its par value, or at a fixed interest rate payable at maturity.

COM (Commercial Paper)

Commercial paper of "prime" quality of the highest ranking or of the highest letter and number rating as provided for by a nationally recognized statistical-rating organization.

CORP (Corporate Notes)

Medium-term notes, defined as all corporate and depository institution debt securities with a maximum remaining maturity of five years or less, issued by corporations organized and operating within the United States or by depository institutions licensed by the United States, or any state and operating within the United States.

FNMA (Federal National Mortgage Association)

A government-sponsored, privately owned corporation established to create a secondary market for Federal Housing Administration mortgages.

LAIF (Local Agency Investment Fund, State of California)

The Treasurer of the State of California administers this investment pool, providing a high-level of liquidity and strong safety through diversification of investments.

MMF (Money Market Fund)

This is a money market interest-bearing checking account that is fully insured and collateralized.

SUPRA (Supra-National Agency Bonds or Notes)

Supranational bonds and notes are debt of international or multi-lateral financial agencies. The debt is used to finance economic/infrastructure development, environmental protection, poverty reduction and renewable energy around the globe, rated AAA, highly liquid and issued in a range of maturities.

TREAS (U.S. Treasury Notes)

A Treasury obligation of the U.S. Government to provide for the cash flow needs of the Federal Government.

INTRODUCTION


The Community Safety Commission met on April 4, 2022 to consider various community safety matters that included the consideration of a request for a disabled person parking space at 4722 Canehill Avenue.


STATEMENT OF FACT

The Public Works Department received a request for a disabled person parking space at 4722 Canehill Avenue. The resident stated that he is requesting the space because he is disabled and uses a wheelchair. He must load and unload at the curb due to the need to use a ramp when entering and exiting his vehicle. The ramp cannot deploy onto a sloped surface, and his driveway is sloped. Parking is limited because of the increase in the number of people sharing single family homes, and an increase in the number of vehicles per family. Staff observed the location, checked the placard number, and recommended installation of a space. The Community Safety Commission, at their regular meeting on April 4, 2022 approved recommending installation.

RECOMMENDATION

The Community Safety Commission recommends that the City Council adopt the attached resolution authorizing installation of a disabled person designated parking space at 4722 Canehill Avenue.

RESOLUTION NO. 2022-17

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
LAKEWOOD ESTABLISHING DISABLED PERSON
DESIGNATED PARKING ON THE EAST SIDE OF CANEHILL
AVENUE WITHIN THE CITY OF LAKEWOOD

THE CITY COUNCIL OF THE CITY OF LAKEWOOD DOES RESOLVE AS
FOLLOWS:

SECTION 1. This Resolution is enacted pursuant to Section 21458 and 22507 of the Vehicle Code of the State of California, and Section 3250.2 of the Lakewood Municipal Code.

SECTION 2. Disabled person designated parking is hereby established on the east side of Canehill Avenue, beginning two hundred thirty (230) feet north of the north curb line of Arbor Road, continuing north for a distance of twenty (20) feet within the City of Lakewood. No vehicle shall stop, stand or park in said parking restriction unless displaying a special identification license plate or placard issued by the Department of Motor Vehicles pursuant to Section 22511.55 of the California Vehicle Code.

SECTION 3. This resolution shall be effective as long as said restriction is painted and posted in accordance with the requirements of Vehicle Code Section 22511.7 of the California Vehicle Code. In addition, this resolution shall be in effect only as long as Dennis Hoover, a physically disabled person, occupies the house at 4722 Canehill Avenue.

SECTION 4. This resolution has been adopted pursuant to a Community Safety Commission recommendation.

SUBJECT: Participant Agreement for the Los Angeles Region Imagery Acquisition Consortium 7 (LARIAC7)

INTRODUCTION

The County of Los Angeles oversees the Los Angeles Region Imagery Acquisition Consortium ("LARIAC7") project. LARIAC7 was established to provide member cities with considerable cost savings related to the acquisition and use of color digital orthophotography (aerial imagery). By participating in LARIAC7, the City of Lakewood ("City") would be able to update its aerial imagery and integrate it, and related data, into its Geographical Information System (GIS). The FY 2021-2022 budget includes a partial appropriation for the acquisition and integration of the digital imagery provided by LARIAC7.

STATEMENT OF FACTS

Digital orthophotography is aerial imagery that has been accurately corrected to ground terrain with the aid of geodetic surveying and photogrammetry. Technological advances in computer hardware, software and storage capacity now allow the large volumes of data created by digital orthophotography to be processed at a reasonable cost. By participating in the LARIAC7 consortium, the City will once again enjoy substantial cost savings due to the consortium's ability to proportionately spread costs across its members.


As with the previous consortium (LARIAC6) project, the LARIAC7 project will provide the City with high resolution aerial imagery that includes the greater Lakewood region, oblique aerial imagery, and exclusive access to online and mobile aerial mapping applications at no additional cost. LARIAC7 will also provide participants with color infrared aerial imagery, building outlines GIS data, annual aerial imagery updates through 2025, and continued access to historical aerial imagery.

The City's cost to participate in LARIAC7 is not to exceed \$29,903. LARIAC7 is accepting payments from multiple fiscal years to reduce the budget impact of a single, large payment. The FY 2021-2022 budget allotted \$10,000 for the initial 33% deposit. FY 2022-2023 funds will include another 33%, and FY 2023-2024 will include the remaining 33% balance to be paid upon the delivery of the digital data in FY2023-2024.

RECOMMENDATION

That the City Council authorize the City Manager to execute the Participant Agreement for the Los Angeles Region Imagery Acquisition Consortium Program (LARIAC7) in an amount not to exceed \$29,903.

This Participant Agreement (Agreement) is made and entered into by and between the County of Los Angeles (County), a political subdivision of the State of California, and **City of Lakewood**, a California city, special district, agency, or educational institution. Each individual city, district, educational institution, or agency is referred to herein individually as a "Participating Entity" and collectively as the "Participating Entities". The County and the Participating Entities are hereinafter referred to collectively as the "Parties" and each individually as a "Party".

- A. **WHEREAS**, County has planned to acquire new digital orthogonal and oblique aerial imagery in the winter of 2023 Project;
- B. **WHEREAS**, County has become aware that various Participating Entities have similar projects currently underway or plans to undertake similar projects in the near future;
- C. **WHEREAS**, in order to avoid the duplication of efforts and costs by the Parties, the Parties desire to pool their resources to collectively undertake the Project; and
- D. **WHEREAS**, the Parties intend to participate in the Project upon the terms and conditions set forth herein below.

NOW, THEREFORE, in consideration of the mutual covenants herein set forth and the mutual benefits to be derived therefrom, the Parties agree as follows:

1. Purpose

The purpose of this Agreement is to provide a vehicle for the collective participation in the Project by the Parties. The Project shall focus on the acquisition of certain aerial imagery digital data which may include, but are not limited to, products listed in Attachment A ("Digital Data"). It is the intent of the Parties that Digital Data shall be acquired under this Agreement for areas within the County of Los Angeles covered by the jurisdictions of the Parties.

2. Responsibilities of the County

- A. Identify and provide specifications for Digital Data (or their derivatives) to the contractors hired to complete the Project.
- B. Develop all necessary procurement documents for necessary services to be provided by one or more qualified contractors in connection with the acquisition and administration of the Digital Data.
- C. Select the most qualified contractor or contractors to provide the necessary services in connection with the acquisition and administration of the Digital Data and thereafter, manage the entire acquisition and administration of the Project.
- D. With the assistance of one or more selected contractors, provide Quality Control (QC) for all Digital Data delivered under this Agreement.
- E. Arrange for the delivery of the Digital Data (or portions thereof) to the Participating Entity upon Project completion.
- F. Provide monthly reports to the Participating Entities on the status of the Project.

3. The Participating Entity Has the Right to

- A. Participate in identifying and providing technical specifications for the Digital Data (or their derivatives).
- B. Provide currently available geodetic points (with necessary standards and accuracy) for County's QC process.
- D. Acquire additional digital aerial products from the contractors through this Agreement, provided that a Statement of Work is provided. County assumes no liability for the completion of these products.

4. Mutual Responsibilities; Maximum Contribution

The Parties shall be mutually responsible for the following:

- A. Financing the acquisition and administration of the Digital Data including, but not limited to, costs related to QC and the subsequent distribution thereof. The total cost of such acquisition and administration (Total Cost) shall be allocated among the Parties and the Participating Entities. The portion of the Total Cost allocated to a Party hereunder shall be hereinafter referred to as the Party's "Maximum Contribution." Each Participating Entity will transfer its Maximum Contribution to a LARIAC account which has been established by the County for this Project (LARIAC Account) and as further described in Paragraph 5 of this Agreement.

The Maximum Contribution of the Participating Entity shall be \$29,903.

B. In the event the Project is terminated for any reason before the execution of any contract with a contractor for the provision of goods and/or services in connection with the Project, each Participating Entity shall be refunded its Maximum Contribution (or such portion of the Maximum Contribution as shall have been paid to the County by such Participating Entity) in its entirety.

5. Payment of Maximum Contribution; Administration of LARIAC Account

A. A Participating Entity shall have the following options in paying its Maximum Contribution to the County hereunder:

- i. The Participating Entity may elect to pay its Maximum Contribution to County in its entirety upon execution of this Agreement.
- ii. The Participating Entity may elect to pay its Maximum Contribution to County as follows: (a) one third (1/3) of the Maximum Contribution in FY 2021-2022; (b) one third (1/3) of the Maximum Contribution in FY 2022-2023; and (c) one third (1/3) of the Maximum Contribution in FY 2023-2024.

B. The LARIAC Account established by the County in connection with the Project, shall be subject to the following:

- i. All funds held in the LARIAC Account shall be used solely for the payment of contractors selected by County to provide goods and services in connection with the Project.
- ii. Any funds held in the LARIAC Account not expended upon the completion of the Project or the termination of this Agreement shall be held, administered, and returned to Parties based on their prorated contribution to the total costs of the Project.

6. General Terms and Conditions

A. This Agreement shall take effect upon execution and shall remain in effect through final delivery of all Digital Data and through the duration of the license-use term.

B. The term of this Agreement may be extended by an Amendment to this Agreement.

C. It is the intention of the Parties that the Participating Entity shall receive, with the delivery of the Digital Data, an unlimited irrevocable perpetual, royalty-free license. The license may be used to, modify, edit, reuse, reproduce, translate, create derivatives, compile, other works based upon the Digital Data,

and combine the data with other contents selected by the Participating Entity in its own operation, with an unlimited number of seats; including, but not limited to Internet and intranet applications, copying, and printing.

D. The Participating Entity shall have the right to transfer, sublicense, and distribute any form of media either now known or hereinafter desired the Digital Data to its subcontractors or consultants on projects which are outsourced from its own operations. In this connection, the Participating Entity shall require each subcontractor or consultant to whom the Digital Data is transferred to execute a written acknowledgement and agreement to abide by such Participating Entity's license to use the Digital Data. Such acknowledgement and agreement is provided in Attachment B (Los Angeles Regional Imagery Acquisition Consortium (LAR-IAC) 7 Authorized User Confidentiality and Non-Disclosure Agreement).

E. Notwithstanding any provision of this Agreement to the contrary, a Participating Entity shall not have the right to sell, resell, or otherwise transfer its license to use the Digital Data to any other person or entity.

F. This Agreement may be amended or modified by County only after collaboration and consultation with the Participating Entities.

G. Nothing in this Agreement shall be construed to give any person or entity, other than the Parties hereto, any legal or equitable right, remedy, or claim under or in respect to this Agreement or any provision herein contained. This Agreement and the provisions hereof are intended to be and are for the sole and exclusive benefit of the Parties.

H. No Party may terminate its participation under this Agreement after the execution of contract(s) for the acquisition of the Digital Data without the prior written consent of County.

I. Any other California city, special district, agency, or educational institution may become a Participating Entity under this Agreement if:

- (i) Such entity executes this Agreement, and
- (ii) Such entity makes its Maximum Contribution to County as provided for under this Agreement. Any such contribution shall be deposited into the LARIAC Account and administered in accordance with subparagraph 5.B of this Agreement.

J. This Agreement may be executed in counterparts and the signed counterparts shall constitute a single instrument. The signatories to this Agreement represent that they have the authority to bind their respective party to this Agreement.

2. Pursuant to Paragraph 11.2 (Authorized Users) of the Agreement, Licensed Products may only be accessed or otherwise used by an Authorized User, which includes any contractor or consultant of an Authorized Entity using the Licensed Products either at the facilities of such Authorized Entity or for any Project (as defined below) of such Authorized Entity.
3. The undersigned is an Authorized User of an Authorized Entity under the Agreement and desires to use the Licensed Products solely for internal, noncommercial use and for purposes no greater than reasonably needed to achieve the objectives of an actual project undertaken in connection with the relationship with the Authorized Entity (“Project”).
4. The undersigned Authorized User understands and agrees that the Licensed Products contain proprietary, trade secret and/or confidential information (“Confidential Information”) of Pictometry. Therefore, by signing this Authorized User Confidentiality and Non-Disclosure Agreement (“NDA”), the Authorized User agrees to use the Licensed Products solely for the Project, which is a nonexclusive, nontransferable and non-assignable right, from the effective date of this NDA until the expiration or termination of the Project for which the undersigned Authorized User was engaged by the particular Authorized Entity.
5. Pictometry and the County acknowledge that the Agreement and certain information and documentation (collectively, “Records”) may be subject to public record requests (e.g., California Public Record Act Request or Freedom of Information Act Request) or other compelled legal disclosure requests (e.g., a subpoena or warrant) (collectively, “Compelled Disclosure Requests”). Should the Authorized Entity reasonably believe that Records, in whole or in part, are subject to production via a valid, properly submitted Compelled Disclosure Request, the Authorized Entity will promptly notify County and Pictometry of such request providing five (5) days advance notice prior to producing any of the requested Records. Pictometry explicitly reserves the right to object to any such production and to pursue any and all remedies it has in both law and in equity to prevent the release of such Records. The Authorized User and the Authorized Entity, at Pictometry’s expense, shall reasonably cooperate with Pictometry in connection with the foregoing.
6. The undersigned Authorized User agrees to protect and maintain any Confidential Information the Authorized User is given access to under this NDA using at least the same protections and to the same extent the Authorized Entity uses to protect and maintain its own confidential information of a similar nature.
7. To the extent any Confidential Information that is not in the public domain is revealed through the operation or other use of the Licensed Products, the Authorized User agrees that it will not make use of, disseminate or in any way disclose such Confidential Information without the County’s prior written consent, which County may first need to obtain from Pictometry.

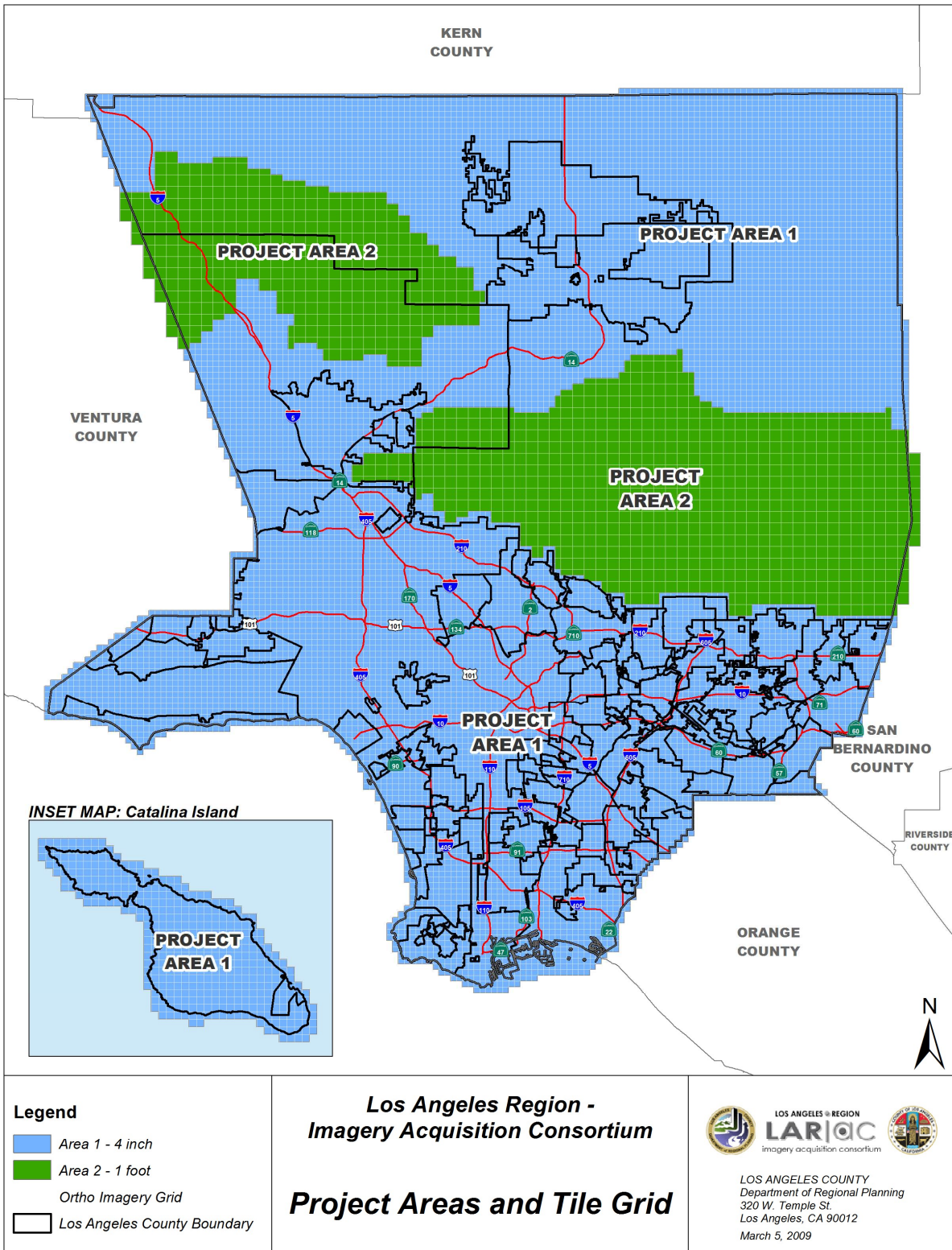

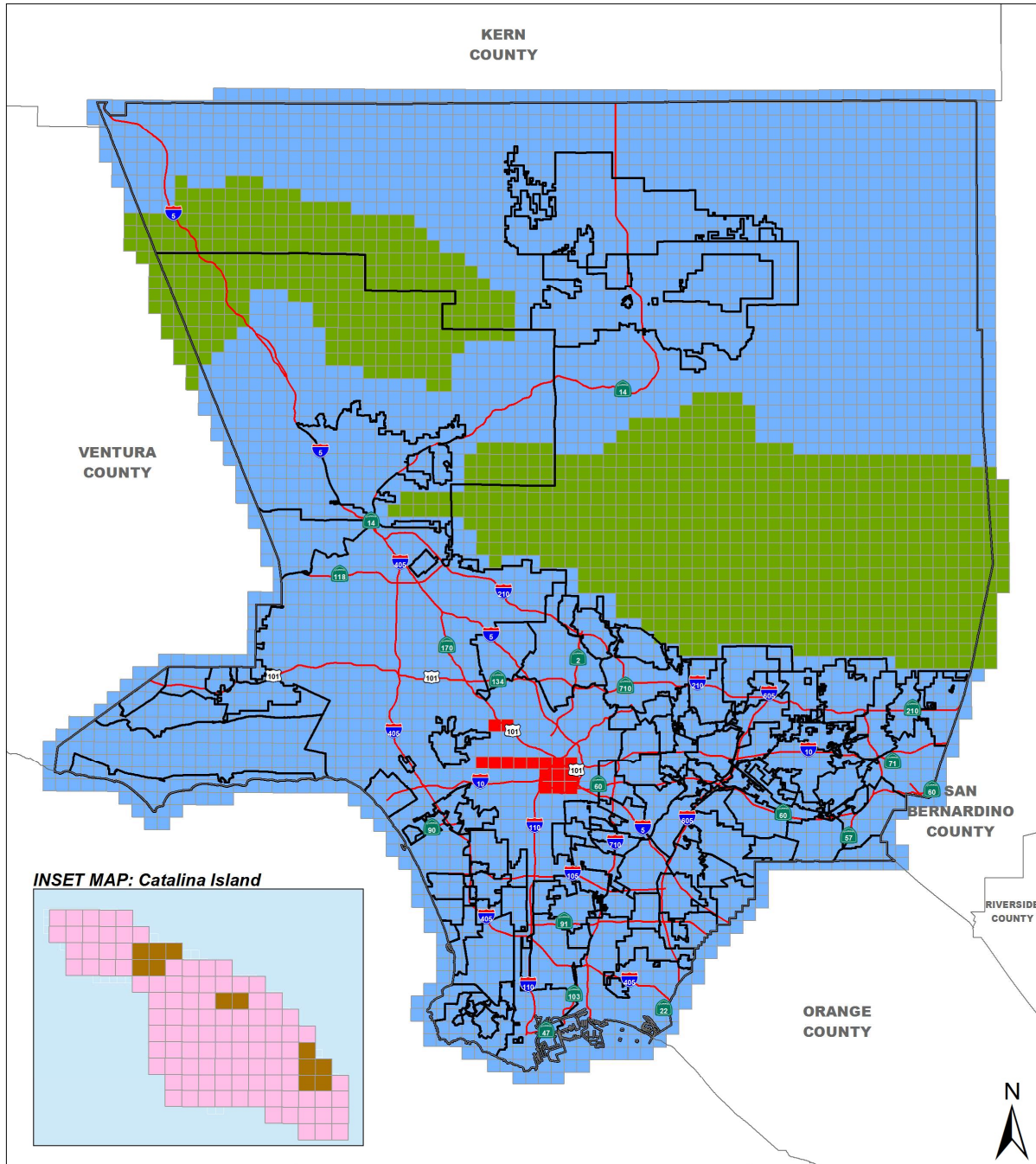

SUBJECT: Resolution Approving the Application for Grant Funds from the Recreational Trails Program for the Development of the Carson Street Multiuse Nature Trail at the Lakewood Equestrian Center

INTRODUCTION

The City of Lakewood is eligible to apply for a competitive grant administered by the California Department of Parks and Recreation (DPR). DPR's Recreational Trails Program (RTP) provides funds annually for recreational trails and trails-related projects.

STATEMENT OF FACT


The objective in submitting an application for grant funding from the California Department of Parks and Recreation is to create a multi-use nature trail featuring connection points with a picnic area, bike stop, and native landscaping along Carson Street at the entrance to the Lakewood Equestrian Center. Current features within the proposed project area include non-native, invasive ice plant and mature pine trees; general signage; fencing; an electronic gate; and limited, controlled access to the Los Angeles County San Gabriel River trail system. The proposed project would keep in place the mature pines and existing signage while enhancing the native landscaping, drainage, educational signage, and connectivity/access points. The multiuse trail would have two connection points: one to the internal bridle trail and one to the San Gabriel River trail system, both ADA and equestrian-friendly. Picnic and viewing areas would allow members of the public to safely rest and enjoy the view of the horses located on the property. The bike stop would increase the activation along this particular area and could be used as a trailhead for cyclists.

The maximum grant award from the Recreational Trails Program cannot exceed 88% of the total project cost. The proposed Carson Street Multiuse Nature Trail at the Lakewood Equestrian Center is estimated at a cost of \$3 million. The city will submit an application requesting \$2 million in grant funding from RTP. The Los Angeles County Measure A competitive grant awarded to the city in March 2022, for \$1 million serves as an eligible match source for RTP grant program.

RECOMMENDATION

It is the recommendation of staff that the City Council approve the resolution for the application of competitive grant funds from the California Department of Parks and Recreation's Recreational Trails Program.

SUBJECT: Award of Bid for Public Works Project No. 2022-03
Asphalt Improvements to the Existing Nixon Yard

INTRODUCTION

On April 4th, 2022 the City Clerk received one informal bid for the Asphalt Improvements to the Existing Nixon Yard, a CUPCCAA project. The work generally consists of asphalt paving improvements for the yard, which is part of the long term strategic infrastructure improvements for this site.

STATEMENT OF FACT

On December 14, 2021, City Council adopted the resolution to become subject to the California Uniform Public Construction Cost Accounting Act (CUPCCAA) and adopted the informal bidding procedures under the act for projects less than \$200,000 (PCC 22032(b)). As part of the act, the City sent notices to designated construction trade journals inviting contractors to join the City’s lists of qualified contractors. The qualified contractors are placed on separate lists based on their categories of work. Contractors are invited to informally bid on projects based on their category of work. R.J. Noble was the only contractor that was placed on the list for asphalt and paving improvements.

RANK	BIDDER	BID AMOUNT
1	R.J. Noble	\$184,059.73

The lowest responsible bidder is R.J. Noble in the lump sum base bid amount of \$184,059.73. This pricing is based on unit cost per ton of asphalt and includes weekend work to minimize the impacts to our daily operations at the yard. Staff has verified with the State Contractors License Board that R.J. Noble is properly licensed for the work. In addition, R.J. Noble has completed successful projects with the City, and are currently conducting the Major & Collector Street Paving FY22 Project. Staff also recommends that a contingency of \$15,940 be included, since there could be unforeseen, unexpected conditions, once construction begins.

Staff recommends appropriating \$200,000 from the General fund reserves to complete this project.

SUMMARY

Bids have been received on Public Works Contract 22-03. Staff recommends the contract be awarded to the lowest responsible bidder, R.J. Noble, and that \$15,940 in project funds be authorized for contingency purposes. In addition, staff recommends that funding be allocated in the project account to fully fund the project.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF

WHEREAS, Article 2 of Chapter 4 of Division 2 of Title 5 of the Government Code pertains to the deposit and investment of funds of local agencies; and

WHEREAS, pursuant thereto the City Treasurer, with the approval of the City Council, may deposit money necessary to pay the principal and interest on bonds in a bank within or without the State at the place where they are payable. The City Treasurer further is required to deposit the funds of the City in active and inactive deposits in State or national banks, with the objective of realizing maximum return, consistent with prudent financial management; and

WHEREAS, the City Council has from time to time authorized the City Treasurer to invest said funds in certain banks; and

WHEREAS, the City Treasurer would have more flexibility and be better able to carry out the mandate of the law if the City Treasurer, from time to time, may make the determination as to those depositories or investments in which the City's funds are to be placed, all subject to the terms and provisions of said Article 2 of Chapter 4 of Division 2 of Title 5 of the Government Code of the State of California.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF LAKEWOOD DOES RESOLVE AS FOLLOWS:

SECTION 1. Resolution No. 2021-9 pertaining to the deposit and withdrawal of funds is hereby repealed.

SECTION 2. Pursuant to Article 2 of Chapter 4 of Division 2 of Title 5 of the Government Code of the State of California, the City Treasurer is hereby authorized and directed to deposit all funds of the City of Lakewood as therein specified in active or inactive accounts bearing the highest rate of interest as specified in said Government Code, or to invest said funds in those securities as therein specified in said Government Code, all subject to the terms and provisions of Chapter 4 of Title 5 of the Government Code of the State of California.

SECTION 3. The City Treasurer is authorized and directed to execute all necessary documents, authorization and depository agreements to carry out the foregoing. Any State or national bank depository is hereby requested, authorized and directed to honor all checks, drafts or other orders for payment drawn in the City's name on said accounts so made and entered into by the City Treasurer under the manual, electronic, or facsimile signature of Thaddeus McCormack or Jose Gomez; and where countersigned by either the manual, electronic, or facsimile signature of _____, Mayor, or that of _____, Mayor Pro Tem. Said depository shall be entitled to honor and to charge to the City of Lakewood for all such checks for the payment of money regardless of, by whom, or by what means the actual or purported facsimile signature or signatures resemble the electronic specimen from time to time filed with the depository by the City Treasurer.

SECTION 4. The City Clerk is directed to certify to the adoption of this resolution and to procure from each depository selected by the City Treasurer the necessary signature clauses, cards, or authorizations. The City Treasurer is directed to keep on file with each depository selected by him the facsimile signature of the Mayor and Mayor Pro Tem and from time to time file with the depository any changes in said facsimile specimen.

SUBJECT: Proposed Ordinance Pertaining to Unlawful Possession of Catalytic Converters

INTRODUCTION

The purpose of this ordinance is to prohibit the unlawful possession of catalytic converters and provide appropriate enforcement measures to protect the public and deter theft of catalytic converters.

STATEMENT OF FACT

Theft of catalytic converters has increased significantly across LA County and the nation, and Lakewood is not immune to this trend. In an effort to combat this trend, staff proposes a new ordinance that will make the possession of a catalytic converter unlawful without proof of ownership.

Catalytic converters contain expensive precious metals including platinum, palladium, and rhodium, which currently cost over \$11,000 per ounce, making them attractive to thieves. Stolen catalytic converters are sold for a substantial profit to be recycled. Victims of catalytic converter theft are left feeling unsafe in the community and a pay substantial cost, as much as \$2,000, to replace the catalytic converter.

Identifying the owner of a stolen catalytic converter is nearly impossible due to the manner in which the theft occurs and lack of identifying marks. This makes the prosecution of catalytic converters difficult and many cases remain unresolved.

Currently, there is no city, state or federal legislation to require proof of ownership of a detached catalytic converter thereby limiting law enforcement's ability to protect the public and deter catalytic converter theft.

Lakewood's efforts to deter catalytic converter theft have included publishing public education materials to provide ways to prevent catalytic converter theft, holding several catalytic converter etching events with more planned in the near future and supporting several proposed bills that combat catalytic converter theft. Specific to the bills, one prohibits the purchase of catalytic converters unless it is purchased from a narrow category of legitimate businesses that generates, possess or sells used catalytic converters. Violation of this law is punishable with a fine between \$1,000 and \$5,000. Another bill the city is supporting would require that a vehicle identification number be engraved or etched onto the catalytic converter prior to sale of the vehicle, and it would also prohibit the cash sales of used catalytic converters by requiring recyclers to accept only traceable payment methods, such as a credit card.

On March 5, 2022, the Public Safety Committee reviewed a draft of the proposed ordinance and recommended that the City Council adopt the ordinance.

RECOMMENDATION

Staff recommends that the City Council introduce the proposed ordinance amending the Lakewood Municipal Code pertaining to unlawful possession of catalytic converters.

ORDINANCE NO. 2022-1

AN ORDINANCE OF THE CITY OF LAKEWOOD AMENDING
ARTICLE III OF THE LAKEWOOD MUNICIPAL CODE
PERTAINING TO UNLAWFUL POSSESSION OF CATALYTIC
CONVERTERS

WHEREAS, the theft of catalytic converters has been an increasing problem regionally and nationally, and Lakewood is not immune to this trend; and

WHEREAS, catalytic converters contain expensive precious metals including platinum, palladium, and rhodium, which currently cost over \$11,000 per ounce; and

WHEREAS, the average cost of replacing a stolen catalytic converter and repairing the damage to the vehicle is generally over \$2,000 to the victim; and

WHEREAS, individuals in possession of stolen catalytic converters often recycle them for substantial profit while victims of these thefts suffer the consequences of paying thousands of dollars in repairs, the inconvenience of repairing their vehicles, and feeling unsafe in the community; and

WHEREAS, catalytic converter thefts are on the rise because individuals are incentivized to commit catalytic converter thefts for multiple reasons including, but not limited to: (1) the ease and undetectable nature of committing the thefts in a matter of seconds using common tools such as a reciprocating saw, (2) the ability to recycle the precious metals contained in catalytic converters at scrap metal yards for high dollar returns, and (3) the challenges with prosecuting criminals for catalytic converter theft where a victim cannot be identified; and

WHEREAS, finding the victim of these crimes is nearly impossible due to the manner in which the catalytic converter thefts occur and lack of identifying markers on catalytic converters to link a stolen catalytic converter to the victim; and

WHEREAS, the inability to identify the victims of catalytic converter thefts has stymied the ability to successfully prosecute individuals for the thefts; and

WHEREAS, due to lack of legislation addressing these thefts, the majority of catalytic converter theft cases are unresolved; and

WHEREAS, there is currently no city, state, or federal legislation applicable within the City of Lakewood requiring individuals to provide proof to law enforcement showing how they obtained detached catalytic converters, thus limiting law enforcement's ability to protect the public by deterring catalytic converter thefts; and

WHEREAS, this Ordinance is necessary to provide a means to protect the public, deter this criminal activity and promote a more productive use of Lakewood resources by staff responsible for investigating catalytic converter thefts.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF LAKEWOOD DOES HEREBY ORDAIN AS FOLLOWS:

SECTION 1. INTENT. Article III Public Safety of the Lakewood Municipal Code is hereby amended as provided in this Ordinance to provide legislative remedies to deter and address catalytic converter thefts.

SECTION 2. PURPOSE. The purpose of this ordinance is to prohibit the unlawful possession of catalytic converters and provide appropriate enforcement measures to protect the public and deter this criminal activity.

SECTION 3. Section 3295 regarding Unlawful Possession of Catalytic Converters of Part 9 of Miscellaneous of Chapter 2 of Article III of the Lakewood Municipal Code is hereby added to read as follows:

3295. UNLAWFUL POSSESSION OF CATALYTIC CONVERTERS

- A. It is unlawful for any person, other than a Core Recycler as defined in California Business and Professions Code Section 21610, to possess any catalytic converter that is not attached to a vehicle unless the person has valid proof of ownership of the catalytic converter.
- B. This section does not apply to a detached catalytic converter that has been tested, certified, and labeled or otherwise approved for reuse, and being bought or sold for purposes of reuse in accordance with the federal Clean Air Act (42 U.S.C. §§ 7401 et seq.) and regulations under the Clean Air Act, as they may, from time to time, be amended.
- C. For purposes of this section, “valid proof of ownership” shall contain all the following information:
1. The license plate number and vehicle identification number of the car from which the catalytic converter was removed.
 2. The name, address, and telephone number of the owner of the vehicle from which the catalytic converter was removed.
 3. The signature of the vehicle owner authorizing removal of the catalytic converter.
 4. The name, address, and telephone number of the current owner of the catalytic converter.
- D. It is unlawful for any person to knowingly falsify or cause to be falsified any information in a record intended to show valid proof of ownership.

E. Each violation of this section constitutes a separate violation and is subject to all remedies and enforcement measures authorized by the Lakewood Municipal Code.

SECTION 4. SEVERABILITY If any section, subsection, subdivision, sentence, clause, phrase, or portion of this Ordinance is for any reason held to be invalid or unconstitutional by the decision of any court of competent jurisdiction, such decision shall not affect the validity of the remaining portions of this Ordinance. The City Council hereby declares that it would have adopted this Ordinance and each section, subsection, subdivision, sentence, clause, phrase, or portion thereof irrespective of the fact that any one or more sections, subsections, subdivisions, sentences, clauses, phrases or portions thereof be declared invalid or unconstitutional.

SUBJECT: Approve Purchase of Radar Trailers with Variable Message Sign

INTRODUCTION

The use of different technology and equipment has proven to improve public safety and are integral components of Lakewood's overall public safety model. Incorporating the use of a radar trailer with variable message sign and can integrate an Automated License Plate Reader camera will further enhance public safety efforts in Lakewood.

STATEMENT OF FACT

A radar trailer equipped with a variable message board and capable of housing an Automated License Plate Reader (ALPR) camera will provide a multi-function platform for addressing various public safety issues. Following are the key features of an available radar trailer.

Radar Speed Feedback

A radar device for measuring vehicle speeds provide motorists with instant feedback of their speed and warns drivers if they are driving over the posted speed limit by displaying the actual speed and a warning such as "slow down" on the message display. A traffic data recording system is coupled with the radar device to record vehicle counts, speeds and time of data. This data can then be used to determine if a speeding problem existing and have better deployment of resources for enforcement.

Variable Message Sign

The message sign is approximately 4' in height and 6' in width and utilizes LED lights to display various messages. As noted above, speed and related messages can be display along with any message. The sign can be used for public education messaging, in conjunction with a special event to provide traffic directions and to inform the public in case of an emergency. The message sign has over 200 pre-set messages and 150 graphics/animations, and can accommodate up to 200 user-defined messages.

Automated License Plate Reader Ready

The radar trailer is equipped with a pedestal mount and 12V wiring to accommodate the installation of an ALPR camera. The camera is not included in the purchase of the radar trailer and would be purchased separately. Once installed, the ALPR would operate independently from the radar trailer, using its own built in cellular connectivity to transfer data to the Sheriff's Department's system. Any "hits" of a stolen or wanted vehicle would send a notification to Lakewood Station dispatch and patrol deputies to respond to the area to locate and stop the vehicle.

Staff has received a quote from Kustom Signals, Inc. in the amount of \$46,080.09 for two SMART VMS HT radar trailers with variable message sign and that are ALPR ready. Pricing for the trailers is based on the NASPO ValuePoint cooperative purchasing contract. NASPO ValuePoint has been the cooperative purchasing arm of NASPO (the National Association of State Procurement Officials) encouraging, fostering and guiding the nation's most significant public contract cooperative. The purchasing policy allows the purchase of equipment through an existing purchase contract obtained through a competitive bidding process prepared by and awarded by another local, state or federal government agency.

Funds are available in the FY2021-22 budget for the purchase of the trailers.

RECOMMENDATION

Staff recommends the City Council approve the purchase of two radar trailers with variable message signs at the proposed contract price of \$46,080.09 from Kustom Signals, Inc. of Lenexa, Kansas.

SUBJECT: Authorize Purchase of Bucket Truck from Terex

INTRODUCTION

The tree department needs a replacement bucket truck, as the existing aged bucket truck is often out of service impeding the tree department's ability to quickly respond to service requests. Staff is seeking authorization to purchase a new bucket truck utilizing the Sourcewell cooperative government purchasing program.

STATEMENT OF FACT

The City's Purchasing Policy allows for purchases to be made on behalf of the City through any governmental entity, including, but not limited to, the State of California, the County of Los Angeles, other cities or special districts, or cooperatives, provided that the entity acquiring the supplies or equipment substantially adhere to the procedures set forth in the policy. Sourcewell, formerly known as the National Joint Powers Alliance (NJPA), is a self-sustaining government organization with over 40 years of dedicated service helping local government operate more efficiently by offering over 400 competitively-bid 400 cooperative contracts. By utilizing cooperative purchasing, government agencies save time during the solicitation process and money by leveraging the combined purchasing power of over 50,000 agencies nationwide.


Sourcewell awarded a cooperative contract to Terex (#110421-TER) for the sale of a full line of equipment including bucket trucks. As a member of Sourcewell, the City of Lakewood is authorized to purchase the bucket truck at a discount of \$12,374 in retail pricing. The total contract amount for the purchase is \$166,861 inclusive of fees and delivery. The final pricing is subject to change due to DMV fees and state/local taxes which may change at time of billing. Sufficient funds have been budgeted for this purchase in Account No. 10106700-58200.

Staff considered trucks from two different manufacturers who make lift trucks for this purpose and they were similarly priced, however, the other manufacturer has quoted a four-year delivery lead time compared to Terex quoted lead time of one year. Current market conditions and supply chain issues have created serious impacts related to purchase and acquisition of materials and equipment.

RECOMMENDATION

Staff recommends that the City Council:

1. Authorize the Purchasing Officer to purchase the bucket truck in the amount of \$166,861.
